THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 182. (1) The governor as commander in chief, commander-
- 2 in-chief may prescribe the award of medals and other suitable means
- 3 of public recognition for distinguished service, longevity, acts of
- 4 valor, or meritorious achievement. The awards may be made to
- 5 members of the organized militia of this state or to other

- 1 individuals, who are not members of the organized militia, who have
- 2 rendered appropriate service to the military establishment. The
- 3 adjutant general shall develop and publish rules to carry out this
- 4 provision.subsection.
- 5 (2) The adjutant general is authorized to award, in the name
- 6 of the legislature, the "Michigan Vietnam veteran recognition
- 7 certificate". The adjutant general, in consultation with the
- 8 director of the Michigan veterans affairs agency, shall develop and
- 9 publish rules to carry out this subsection. All of the following
- 10 apply to the certificate:
- 11 (a) An individual may be awarded the certificate if the
- 12 individual meets all of the following requirements:
- 13 (i) The individual is a citizen of this state or was a citizen
- 14 of this state while serving in the Armed Forces of the United

- 23 their service. To receive this designation, an individual must

- 25 military and veterans affairs that while serving in the Armed
- 26 Forces of the United States, he or she was exposed to dioxin or
- 27 phenoxy herbicides, as evidenced by a medical diagnosis of a
- 28 disease associated with dioxin or phenoxy herbicides and any other
- 29 proof required by the adjutant general.

- 1 (c) An individual shall not be awarded more than 1 certificate.
- 3 (d) If the certificate recipient is deceased, the certificate
 4 may be presented to a designated representative of the deceased.
- 5 (3) As used in this section:
- 6 (a) "Armed Forces of the United States" means the United
- 7 States Army, Navy, Marine Corps, Air Force, or Coast Guard,
- 8 including the Michigan National Guard and reserve components.
- 9 (b) "Certificate" means the Michigan Vietnam veteran
- 10 recognition certificate.
- 11 (c) "Vietnam War era" means the period beginning on February
- 12 28, 1961 and ending on May 7, 1975.
