A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 1114 (MCL 436.2114), as amended by 2011 PA 27, and by adding section 1116.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1114. (1) Notwithstanding R 436.1403 and R 436.1503 of the Michigan administrative code Administrative Code and except as otherwise provided under this act, or by rule of the commission, an on-premises and an off-premises licensee shall not sell, give away,

- 1 or furnish alcoholic liquor between the hours of 2 a.m. and 7 a.m.
- 2 on any day.
- 3 (2) Subsection (1) does not prevent any a local governmental
- 4 unit from prohibiting the sale of beer and wine between the hours
- 5 of 7 a.m. and 12 noon on Sunday or between the hours of 7 a.m. on
- 6 Sunday and 2 a.m. on Monday under section 1111 and does not prevent

- 20 (2) The commission may issue a late night permit for the sale

- 24 on the premises that is located in a city, village, or township
