

**SUBSTITUTE FOR
HOUSE BILL NO. 4150**

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 802 (MCL 257.802), as amended by 2019 PA 88.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 802. (1) For a special registration issued under section
2 226(8), the registrant shall pay 1/2 the tax imposed under section
3 801 and a service fee of \$10.00.

4 (2) For all commercial vehicles registered after August 31 for
5 the period expiring the last day of February, the secretary of
6 state shall collect a tax of 1/2 the rate otherwise imposed under
7 this act. This subsection does not apply to vehicles registered by
8 manufacturers or dealers under sections 244 to 247.

9 (3) For each special registration under section 226(9), the

1 secretary of state shall collect a service fee of \$10.00.

2 (4) For temporary registration plates or markers under section
3 226a(1), the secretary of state shall collect a service fee in an
4 amount determined by the secretary of state to reflect the actual
5 cost of administering the temporary registration plates and markers
6 program, or in the amount of \$4.00 per plate or marker, whichever
7 is less.

8 (5) For a temporary registration under section 226b, the fee
9 is either of the following:

10 (a) For a 30-day temporary registration, 1/10 of the tax
11 prescribed under section 801 or \$20.00, whichever is greater, and
12 an additional \$10.00 service fee.

13 (b) For a 60-day temporary registration, 1/5 of the tax
14 prescribed under section 801 or \$40.00, whichever is greater, and
15 an additional \$10.00 service fee.

16 (6) For registration plates as provided for in section
17 226a(5), (6), and (7), the secretary of state shall collect a
18 service fee of \$40.00 for 2 registration plates and \$20.00 for each
19 additional registration plate.

20 (7) For special registrations issued for special mobile
21 equipment as provided in section 216(d), the secretary of state
22 shall collect a service fee of \$15.00 each for the first 3 special
23 registrations, and \$5.00 for each special registration issued in
24 excess of the first 3.

25 (8) The secretary of state, upon request, may issue a
26 registration valid for 3 months for use on a vehicle with an
27 elected gross weight of 24,000 pounds or greater on the payment of
28 1/4 the tax provided in section 801(1)(k) and a service fee of
29 \$10.00.

1 (9) Upon application to the secretary of state, an owner of a
2 truck, truck tractor, or road tractor that is used exclusively for
3 the purpose of gratuitously transporting farm crops or livestock
4 bedding between the field where produced and the place of storage,
5 feed from on-farm storage to an on-farm feeding site, or
6 fertilizer, seed, or spray material from the farm location to the
7 field may obtain a special registration. **A person who obtains a**
8 **special registration under this subsection shall use the motor**
9 **vehicle exclusively for the purposes described in this subsection.**
10 **A person who violates this subsection is responsible for a civil**
11 **infraction.** The service fee for each special registration issued
12 under this subsection is \$20.00. The special registration is valid
13 for a period of up to 12 months and expires on December 31. As used
14 in this subsection:

15 (a) "Feed" means hay or silage.

16 (b) "Livestock bedding" means straw, sawdust, or sand.

17 (10) The secretary of state, upon request, may issue a special
18 registration valid for 3 or more months for a road tractor, truck,
19 or truck tractor owned by a farmer, if the motor vehicle is used
20 exclusively in connection with the farmer's farming operations or
21 for the transportation of the farmer and the farmer's family and
22 not used for hire. **A person who obtains a special registration**
23 **under this subsection shall use the motor vehicle exclusively for**
24 **the purposes described in this subsection. A person who violates**
25 **this subsection is responsible for a civil infraction.** The fee for
26 the registration is 1/10 of the tax provided in section 801(1)(c)
27 times the number of months for which the special registration is
28 requested and, in addition, a service fee of \$10.00. The secretary
29 of state shall not issue a special registration for a motor vehicle

1 for which the tax under section 801(1)(c) would be less than
2 \$50.00.

3 (11) The secretary of state, upon request, may issue a
4 registration valid for 3 months or more for use on a vehicle with
5 an elected gross weight of 24,000 pounds or greater. The fee for
6 the registration shall be 1/12 of the tax provided in section
7 801(1)(k), times the number of months for which the special
8 registration is requested and, in addition, a service fee of
9 \$10.00.

10 (12) The secretary of state shall deposit the service fees
11 collected under subsections (1), (3), (4), (5), (6), (7), (8), (9),
12 (10), and (11) in the transportation administration collection fund
13 created in section 810b through October 1, 2023.

14 Enacting section 1. This amendatory act takes effect October
15 1, 2021.

16 Enacting section 2. This amendatory act does not take effect
17 unless House Bill No. 4153 of the 101st Legislature is enacted into
18 law.
