## **HOUSE BILL NO. 5045**

A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

by amending section 11b (MCL 722.121b), as amended by 2017 PA 258.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11b. (1) The department shall establish and maintain a
- 2 database of child care centers, family child care homes, and group

- 1 child care homes. The database shall must include, at a minimum,
- 2 all of the following information:
- 3 (a) The name, address, and telephone number of the child care
- 4 center, family child care home, or group child care home.
- 5 (b) The days and general hours of operation of the child care
- 6 center, family child care home, or group child care home.
- 7 (c) The license number, effective date, expiration date, and
- 8 date of the last inspection of the child care center, family child
- 9 care home, or group child care home.
- 10 (d) The number and nature of any adverse action taken against
- 11 the child care center, family child care home, or group child care
- 12 home by the department.
- 13 (e) The number and nature of any special investigations
- 14 regarding the child care center, family child care home, or group
- 15 child care home conducted by the department. This information shall
- 16 remain in the database as long as the licensee is licensed under
- 17 this act.
- 18 (2) The department shall must make the following database
- 19 information available to the public on the internet for persons
- 20 seeking information on child care options, without charge, through
- 21 that department's website:
- 22 (a) The items listed in subsection (1)(a) to (c).
- 23 (b) The results of any monitoring inspections conducted in the
- 24 past 3 years and information on corrective actions taken, if

  4 releases or other media avenues, of the information available as
