SUBSTITUTE FOR HOUSE BILL NO. 5261

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 9145 (MCL 333.9145), as added by 2018 PA 554.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9145. (1) The department shall develop a nonopioid
- 2 directive form indicating to health professionals and emergency
- 3 medical services personnel that, except as otherwise provided in
- 4 subsection (3) or in rules promulgated by the department under
- 5 subsection (5), an individual who has executed the form or who has
- 6 had a form executed on the individual's behalf must not be
- 7 administered an opioid or offered a prescription for an opioid. The
- 8 department shall include on the nonopioid directive form
- 9 instructions on how the form may be revoked and any other

- 1 information that the department considers relevant. The department
- 2 shall make the form available to the public on the department's
- 3 internet website.
- 4 (2) An individual may execute a nonopioid directive form on
- 5 his or her own behalf. A guardian or patient advocate of an
- 6 individual may execute a nonopioid directive form on behalf of the
- 7 individual. If a nonopioid directive form is executed by or on
- 8 behalf of an individual and is presented to a health professional,
- 9 the health professional shall obtain a copy of the form and include
- 10 the copy in the individual's medical record. An individual may
- 11 revoke a nonopioid directive form executed by himself or herself at
- 12 any time and in any manner by which he or she is able to
- 13 communicate his or her intent to revoke the form. A patient
- 14 advocate or quardian may revoke a nonopioid directive form on
- 15 behalf of an individual at any time by issuing the revocation in
- 16 writing and providing notice of the revocation to the individual's
- 17 health professional or his or her delegatee.
- 18 (3) A prescriber who holds a controlled substances license
- 19 under article 7 or a health professional who is a practical nurse
- 20 or registered professional nurse and is acting on the order of the
- 21 prescriber may administer an opioid to an individual who has
- 22 executed a nonopioid directive form or who has had a nonopioid
- 23 directive form executed on his or her behalf if the any of the
- 24 following apply:
- **25** (a) The individual is being treated at a hospital or in a
- 26 setting outside of a hospital in the case of an emergency and, in
- 27 the prescriber's professional opinion, the administration of the
- 28 opioid is medically necessary to treat the individual. If an opioid
- 29 is administered under this subsection, subdivision, the prescriber

- 1 shall ensure that the individual is provided with information on
- 2 substance use disorder services as that term is defined in section
- **3** 6230.
- 4 (b) The opioid is for intraoperative use.
- 5 (4) Except as otherwise provided by law, the following are not
- 6 subject to civil or criminal liability or professional disciplinary
- 7 action for failing to administer, prescribe, or dispense an opioid,
- 8 or for the inadvertent administration of an opioid, to an
- 9 individual who has executed a nonopioid directive form or who has
- 10 had a nonopioid directive form executed on his or her behalf, if
- 11 the failure to act or act was done reasonably and in good faith:
- 12 (a) A health professional whose scope of practice includes the
- 13 prescribing, administering, or dispensing of a controlled
- 14 substance.
- 15 (b) A health facility or agency licensed under article 17.
- 16 (c) An employee of a health professional.
- 17 (d) An employee of a health facility or agency licensed under
- **18** article 17.
- 19 (e) Emergency medical services personnel.
- 20 (5) Subject to subsection (6), the department shall promulgate
- 21 rules to implement this section. The rules must include, but not be
- 22 limited to, all of the following:
- 23 (a) Procedures to record a nonopioid directive form in a
- 24 medical record, including an electronic medical record.
- 25 (b) Procedures to revoke a nonopioid directive form.
- 26 (c) Procedures to ensure that the recording, disclosure, or
- 27 distribution of data relating to a nonopioid directive form or the
- 28 transmission of a nonopioid directive form complies with state and
- 29 federal confidentiality and consent laws, rules, and regulations.

- (d) Exemptions for administering or prescribing an opioid to
 an individual who has executed a nonopioid directive form or who
 has had a nonopioid directive form executed on his or her behalf if
- 4 the opioid is administered or prescribed to treat the individual
- 5 for a substance use disorder.
- 6 (e) Exemptions for administering or prescribing an opioid to
 7 an individual who has executed a nonopioid directive form or who
- 8 has had a nonopioid directive form executed on his or her behalf if
- 9 the individual is a hospice patient.
- 10 (6) The rules promulgated under this section must allow a
- 11 health professional or health facility or agency licensed under
- 12 article 17 to incorporate a nonopioid directive form into an
- 13 existing patient form or into other documentation used by the
- 14 health professional or health facility or agency.
- 15 (7) As used in this section:
- 16 (a) "Emergency medical services personnel" means that term as
 17 defined in section 20904.
- 18 (b) "Guardian" means a person with the powers and duties to
 19 make medical treatment decisions on behalf of a patient to the
 20 extent granted by court order under section 5314 of the estates and
 21 protected individuals code, 1998 PA 386, MCL 700.5314.
- (c) "Health professional" means an individual who is licensedunder article 15.
- (d) "Nonopioid directive form" or "form" means the nonopioiddirective form developed by the department under subsection (1).
- (e) "Patient advocate" means an individual designated to make
 medical treatment decisions for a patient under sections 5506 to
 5515 of the estates and protected individuals code, 1998 PA 386,
- **29** MCL 700.5506 to 700.5515.

1 (f) "Prescriber" means that term as defined in section 17708.
