THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 182. (1) The governor as commander in chief, commander-

- 3 of public recognition for distinguished service, longevity, acts of

- 2 rendered appropriate service to the military establishment. The

- 5 (2) The adjutant general is authorized to award the "Michigan
- 6 Vietnam veteran recognition certificate". The adjutant general, in
- 7 consultation with the director of the Michigan veterans affairs
- 8 agency, shall develop and publish rules to carry out this
- 9 subsection. All of the following apply to the certificate:
- 10 (a) An individual may be awarded the certificate if the

- 2 (d) If the certificate recipient is deceased, the certificate
- 3 may be presented to a designated representative of the deceased.
- 4 (3) As used in this section:
- 5 (a) "Armed Forces of the United States" means the United
- 6 States Army, Navy, Marine Corps, Air Force, or Coast Guard,
- 7 including the Michigan National Guard and reserve components.
- 8 (b) "Certificate" means the Michigan Vietnam veteran
- 9 recognition certificate.
- 10 (c) "Vietnam War era" means the period beginning on February
- 11 28, 1961 and ending on May 7, 1975.
