

**SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4075**

A bill to amend 1956 PA 62, entitled
"An act to authorize the director of the department of state police
to promulgate a uniform traffic code; to authorize a city,
township, or village to adopt the uniform traffic code by reference
without publication in full; and to prescribe criminal penalties
and civil sanctions for violation of the code,"
by amending section 1 (MCL 257.951), as amended by 2006 PA 297.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. (1) A city, township, or village may adopt by
2 reference a code or ordinance for the regulation of traffic within
3 cities, townships, and villages that has been promulgated by the
4 director of the department of state police. The director of the
5 department of state police may promulgate a uniform traffic code in
6 compliance with the administrative procedures act of 1969, 1969 PA

1 306, MCL 24.201 to 24.328.

2 (2) A city, township, or village, with the consent of, or at
3 the request of, a person who is in charge of a parking lot, whether
4 or not that parking lot is open to the general public, may contract
5 with that person for the city, township, or village to enforce
6 provisions of the uniform traffic code or ordinance adopted under
7 this section in that parking lot. A peace officer may enter upon a
8 private road that is accessible to the general public to enforce
9 provisions of an ordinance adopted under this section if signs
10 meeting the requirements of the Michigan manual ~~of~~**on** uniform
11 traffic control devices are posted on the private road. The owner
12 or person in charge of the private road is responsible for the
13 posting of signs under this subsection. ~~Nothing in this~~**This**
14 subsection ~~shall be considered to~~**does not** affect a contract
15 entered into between a city, township, or village and the person in
16 charge of a private road before ~~the effective date of the~~
17 ~~amendatory act that added this sentence.~~**July 20, 2006.** As used in
18 this subsection, "person" means an individual, corporation,
19 association, partnership, or other legal entity.

20 (3) A uniform traffic code promulgated by the director of the
21 department of state police under this section ~~shall~~**must** specify
22 whether a person who violates a particular provision of the code is
23 guilty of a misdemeanor or is responsible for a civil infraction.
24 The director may establish civil sanctions for civil infractions,
25 except that a civil sanction in excess of that prescribed in the
26 vehicle code is in conflict with that act and is void to the extent
27 of the conflict. The uniform traffic code ~~shall~~**must** not impose a
28 criminal penalty for an act or omission that is a civil infraction
29 under the vehicle code.

1 (4) Violation of a provision designated a civil infraction in
2 the uniform traffic code ~~shall~~**must** be processed in the same manner
3 as a civil infraction under the vehicle code.

4 (5) Notwithstanding the requirements of the uniform traffic
5 code, **except as otherwise provided in this subsection**, a sign
6 designating a parking space for persons with disabilities ~~shall~~
7 **must** be 12 inches by 18 inches or larger and ~~shall~~**must** be either
8 blue or white and at a minimum contain the international
9 ~~handicapped~~**symbol of access** in contrasting colors of either blue
10 or white in the center of the sign. **A sign designating a parking**
11 **space for persons with disabilities that is erected or replaced on**
12 **or after the effective date of the amendatory act that added this**
13 **sentence must be 12 inches by 18 inches or larger and must use the**
14 **design adopted under section 102a of the persons with disabilities**
15 **civil rights act, 1976 PA 220, MCL 37.1102a, must not include the**
16 **word "handicapped", and may include a word providing instruction,**
17 **such as "reserved".**

18 (6) The provisions of the uniform traffic code promulgated
19 ~~pursuant to~~**under** this act that relate to driving while under the
20 influence of an alcoholic beverage or driving with impaired ability
21 ~~shall~~**must** be identical to the provisions of sections 625 to 625m
22 of the ~~Michigan vehicle code, 1949 PA 300, MCL 257.625 to 257.625m.~~

23 (7) For purposes of this section, "vehicle code" means the
24 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923.

25 Enacting section 1. This amendatory act takes effect 90 days
26 after the date it is enacted into law.

27 Enacting section 2. This amendatory act does not take effect
28 unless House Bill No. 4076 of the 101st Legislature is enacted into
29 law.
