THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 61. (1) Except as otherwise defined in this article, as 2 used in this article:
- 3 (a) "Serious misdemeanor" means 1 or more of the following:
- 4 (i) A violation of section 81 of the Michigan penal code, 1931
- 5 PA 328, MCL 750.81, assault and battery, including domestic
- 6 violence.
- 7 (ii) A violation of section 81a of the Michigan penal code,

- 1 1931 PA 328, MCL 750.81a, assault; infliction of serious injury,
- 2 including aggravated domestic violence.
- 3 (iii) Beginning January 1, 2023, a violation of section 81c(1)
- 4 of the Michigan penal code, 1931 PA 328, MCL 750.81c, threatening a
- 5 department of health and human services' employee with physical
- 6 harm.
- 7 (iv) (iii)—A violation of section 115 of the Michigan penal code,
- 8 1931 PA 328, MCL 750.115, breaking and entering or illegal entry.
- 9 (v) $\frac{(iv)}{(iv)}$ A violation of section 136b(7) of the Michigan penal
- 10 code, 1931 PA 328, MCL 750.136b, child abuse in the fourth degree.
- 11 (vi) (v) A violation of section 145 of the Michigan penal code,
- 12 1931 PA 328, MCL 750.145, contributing to the neglect or
- 13 delinquency of a minor.
- 14 (vii) (vi) A misdemeanor violation of section 145d of the

- 2 if the violation results in physical injury or death to any

- 4 (xxi) (xxi)—A violation of section 80176(1) or (3) of the
- 5 natural resources and environmental protection act, 1994 PA 451,
- 6 MCL 324.80176, operating a vessel while under the influence of or
- 7 impaired by intoxicating liquor or a controlled substance, or with
- 8 an unlawful blood alcohol content, if the violation involves an
- 9 accident resulting in damage to another individual's property or
- 10 physical injury or death to any individual.
- 11 (xxii) (xvii) A violation of a local ordinance substantially
- 12 corresponding to a violation enumerated in subparagraphs (i) to
- 13 $\frac{(xvi)}{\cdot} (xxi)$.
- 14 (xxiii) (xviii) A violation charged as a crime or serious
- 15 misdemeanor enumerated in subparagraphs (i) to (xxii) (xxii) but
- 16 subsequently reduced to or pleaded to as a misdemeanor. As used in
- 17 this subparagraph, "crime" means that term as defined in section 2.
- 18 (b) "Crime victim services commission" means that term as

- 27 (iii) A parent, quardian, or custodian of a victim who is less
- 28 than 18 years of age and who is neither the defendant nor
- 29 incarcerated, if the parent, guardian, or custodian so chooses.

- $\mathbf{1}$ (iv) A parent, guardian, or custodian of a victim who is so
- 2 mentally incapacitated that he or she cannot meaningfully
- 3 understand or participate in the legal process if he or she is not
- 4 the defendant and is not incarcerated.
- (v) For the purpose of submitting or making an impact
- $\mathbf{6}$ statement only, if the victim as defined in subparagraph (i) is
- 7 deceased, is so mentally incapacitated that he or she cannot
- 8 meaningfully understand or participate in the legal process, or
- 9 consents to the designation as a victim of the following
- 10 individuals other than the defendant:
- 11 (A) The spouse of the victim.
- 12 (B) A child of the victim if the child is 18 years of age or
- 13 older.
- 14 (C) A parent of the victim.
- 15 (D) The guardian or custodian of a child of the victim if the
- 16 child is less than 18 years of age.
- 17 (E) A sibling of the victim.
- 18 (F) A grandparent of the victim.
- 19 (G) A quardian or custodian of the victim if the victim is
- 20 less than 18 years of age at the time of the commission of the
- 21 crime and that guardian or custodian is not incarcerated.
- 22 (2) If a victim as defined in subsection (1) (h) (i) is
- 23 physically or emotionally unable to exercise the privileges and
- 24 rights under this article, the victim may designate his or her
- 25 spouse, child 18 years of age or older, parent, sibling, or

- 27 neither the defendant nor incarcerated to act in his or her place

- 4 (3) An individual who is charged with a serious misdemeanor, a 5 crime as defined in section 2, or an offense as defined in section 6 31 arising out of the same transaction from which the charge 7 against the defendant arose is not eligible to exercise the 8 privileges and rights established for victims under this article.
- 9 (4) An individual who is incarcerated is not eligible to 10 exercise the privileges and rights established for victims under 11 this article except that he or she may submit a written statement 12 to the court for consideration at sentencing.
