

# HOUSE BILL NO. 5695

January 26, 2022, Introduced by Reps. Wendzel and Young and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled  
"Michigan liquor control code of 1998,"  
by amending section 707 (MCL 436.1707), as amended by 2008 PA 11.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 707. (1) A vendor shall not sell, serve, or furnish any  
2 alcoholic liquor to ~~any person~~**an individual** in an intoxicated  
3 condition.

4       (2) A licensee shall not allow ~~a person~~**an individual** who is  
5 in an intoxicated condition to consume alcoholic liquor on the  
6 licensed premises.

1 (3) A licensee, or the clerk, servant, agent, or employee of a  
2 licensee, shall not be in an intoxicated condition on the licensed  
3 premises.

4 (4) A licensee shall not allow an intoxicated ~~person~~  
5 **individual** to frequent or loiter on the licensed premises except  
6 ~~where if~~ the intoxicated ~~person~~ **individual** has been refused service  
7 of further alcoholic liquor and ~~continues to remain~~ **remains** on the  
8 premises for the purpose of eating food, seeking medical attention,  
9 **or** arranging transportation that does not involve driving himself  
10 or herself, or **in** any other circumstances where requiring the  
11 ~~person~~ **individual** to vacate the premises immediately would be  
12 considered dangerous to ~~that person~~ **the individual** or to the  
13 public.

14 (5) A licensee shall not allow a minor to consume alcoholic  
15 liquor or to possess alcoholic liquor for personal consumption on  
16 the licensed premises.

17 (6) A licensee shall not allow ~~any person~~ **an individual who is**  
18 less than 18 years of age to sell or serve alcoholic liquor. **This**  
19 **subsection does not prohibit a wholesaler's employee who is 16**  
20 **years of age or older from doing any of the following:**

21 (a) Building a display of those brands that are represented or  
22 sold by the wholesaler for an off-premises retailer.

23 (b) Marking the price on those brands that are represented or  
24 sold by the wholesaler for an off-premises retailer.

25 (c) Rotating brands that are represented or sold by the  
26 wholesaler for an off-premises retailer.

27 (d) Placing brands that are represented or sold by the  
28 wholesaler on shelves for an off-premises retailer.

29 (7) A licensee shall not allow ~~any person~~ **an individual who is**

1 less than 18 years of age to work or entertain on a paid or  
2 voluntary basis on the licensed premises unless the ~~person~~  
3 **individual** is employed in compliance with the youth employment  
4 standards act, 1978 PA 90, MCL 409.101 to 409.124. This subsection  
5 does not apply to an entertainer under the direct supervision and  
6 control of his or her parent or legal guardian.
