SUBSTITUTE FOR HOUSE BILL NO. 6130

A bill to amend 2020 PA 68, entitled "Michigan reconnect grant recipient act," by amending sections 11, 13, 15, 16, 17, 18, 21, and 23 (MCL 390.1711, 390.1713, 390.1715, 390.1716, 390.1717, 390.1718, 390.1721, and 390.1723).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 11. (1) This act shall be known and may be cited as the
 "Michigan reconnect grant recipient act".
- 3 (2) The reconnect initiative and the reconnect program created4 respectively in this act and the Michigan reconnect grant act, 2020
- 5 PA 84, MCL 390.1701 to 390.1709, are intended to provide last-
- 6 dollar financial assistance to individuals age 25 and older seeking
- 7 associate degrees or industry-recognized certificates or

- 1 credentials; to provide those individuals with greater access to
- 2 the education and skills needed to succeed in, and meet the demands
- 3 of, an evolving economy in which there is continuing demand for a
- 4 talented local workforce; to drive innovations specific to adult
- 5 learners in this state's community colleges; to mitigate
- 6 educational equity gaps in the furtherance of individual
- 7 prosperity; and to achieve the goal of increasing the number of
- 8 residents ages 25 to 64 with a college degree or skill certificate
- 9 or credential to 60% by 2030.
- Sec. 13. As used in this act:
- 11 (a) "Continuous enrollment" means enrollment in at least 2
- 12 semesters or the equivalent in terms or quarters, as determined by
- 13 the department, during each 12-month period for a number of
- 14 consecutive years. For purposes of this subdivision, the 2 or more

Gift aid must be credited first to the student's tuition and mandatory fees. The amount of a Michigan reconnect grant awarded to a Michigan reconnect grant student under this act must not exceed the following, as applicable:

- 5 (2) If awarded, Michigan reconnect grant money must be paid to6 the eligible institution for credit to the student's account.
- 7 Sec. 18. (1) A Michigan reconnect grant student who, with the 8 approval of the eligible institution, takes a leave of absence from 9 an the eliqible institution due to a medical or family hardship 10 may, subject to department approval, continue to receive the grant 11 upon resuming the student's education at an eligible institution if 12 the student continues to meet all applicable eligibility requirements. A leave of absence under this subsection does not 13 14 disrupt the minimum-credit requirement of continuous enrollment 15 under section 16(b) and does not count toward the 4-year limitation
- 17 (2) A student is eligible for a Michigan reconnect grant until18 the occurrence of either of the following:

- 2 (4) Repayment of any Michigan reconnect grant money received 3 by a Michigan reconnect grant student who withdraws from a course 4 of study or degree program must be determined in accordance with 5 the department of treasury's state program procedures manual for 6 financial aid professionals.

 initiative short-term training program is created in the department

 for the purpose of providing skills scholarships to individuals

- 29 under section 21(1)(a) to (c); and (b); the total number of

- programs approved; a list of the names or short descriptions of
 each of those approved programs; and the total number and amount of
 skills scholarships that were awarded for each approved program.
- 4 (c) The total number of individuals who applied for skills scholarships under section 21(1)(f)(ii); 21(1)(e)(ii); the total number of individuals awarded skills scholarships; and the total number of skills scholarships recipients who completed qualified occupational training programs.
- 9 (d) Any other relevant information, as determined by the 10 department.
- Enacting section 1. This amendatory act does not take effect unless House Bill No. 6129 of the 101st Legislature is enacted into law.
