The paint marks shall be not more than 100 feet apart and shall be placed so that they are readily visible to persons approaching the property.

- 1 or enclose the property of another person to prohibit hunting,

- 5 Enacting section 1. This amendatory act takes effect 90 days
- 6 after the date it is enacted into law.
