## **SENATE BILL NO. 486**

May 26, 2021, Introduced by Senator MCBROOM and referred to the Committee on Natural Resources.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 43540e (MCL 324.43540e), as added by 2012 PA 520.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 43540e. (1) The wolf management advisory council is
  created within the department.
- 3 (2) The council shall consist of at least the following
- 4 members:

- 1 (a) The director of the department or his or her designee.
- 2 (b) One member representing an organization that promotes
- 3 conservation in this state appointed by the director or his or her4 designee.
- 5 (c) One member representing organizations that promote hunting
- **6** or fishing in this state appointed by the director or his or her
- 7 designee.
- **8** (d) One member representing a tribal government appointed by
- 9 the director or his or her designee.
- 10 (e) One member representing agricultural interests appointed
- 11 by the director or his or her designee.
- 12 (f) One member representing an animal advocacy organization
- 13 appointed by the director or his or her designee.
- 14 (3) Except as otherwise provided in subsection (4), each
- 15 member of the council must be a resident of the Upper Peninsula.
- 16 (4) If the department determines through winter track surveys
- 17 and genetic testing that wolves are present in the Lower Peninsula,
- 18 a majority of the members of the council must be residents of the
- 19 Upper Peninsula.
- 20 (5)  $\frac{(3)}{(3)}$  The council shall meet at least annually.
- 21 (6) (4)—A majority of the members of the council constitute a
- 22 quorum for the transaction of business at a meeting of the council.
- 23 A majority of the members present and serving are required for
- 24 official action of the council.
- 25 (7) (5) The business that the council may perform shall must
- 26 be conducted at a public meeting of the council held in compliance
- 27 with the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.
- 28 (8) (6) A writing prepared, owned, used, in the possession of,
- 29 or retained by the council in the performance of an official

- 1 function is subject to the freedom of information act, 1976 PA 442,
- 2 MCL 15.231 to 15.246.
- 3 (9) (7) Members of the council shall serve without
- 4 compensation. However, members of the council may be reimbursed for
- 5 their actual and necessary expenses incurred in the performance of
- 6 their official duties as members of the council.
- 7 (10) (8) The council shall annually submit to the commission
- 8 and to the legislature a report that makes nonbinding
- 9 recommendations as to the proper management of wolves in this
- 10 state.
