## **SENATE BILL NO. 1133**

June 30, 2022, Introduced by Senator SCHMIDT and referred to the Committee on Economic and Small Business Development.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending section 2567a (MCL 600.2567a), as amended by 2006 PA 662.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2567a. (1) Except as otherwise provided in subsection
- 2 (4), the county register of deeds shall collect a fee for recording
- 3 any instrument. Before January 1, 2023, 2043, the fee shall be is
- 4 \$4.00. Beginning January 1, <del>2023, 2043</del>, the fee <del>shall be is</del> \$2.00.
- 5 The fee shall must be paid when the instrument is left for record.
- 6 (2) The fee required by this section is in addition to any

- 3 (3) The fees collected under this section shall must be
- 4 remitted to the state treasurer quarterly, and shall must be

- 7 act, 1990 PA 345, MCL 54.271, except that a county may retain not
