THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3801. (1) A building, vehicle, boat, aircraft, or place
- 2 is a nuisance if 1 or more of the following apply:
- 3 (a) It is used for the purpose of lewdness, assignation,
- 4 prostitution, commercial sexual activity, or gambling.
- 5 (b) It is used by, or kept for the use of, prostitutes persons

- 1 who provide or offer to provide commercial sexual activity or other
- 2 disorderly persons.
- 3 (c) It is used for the unlawful manufacture, transporting,
- 4 sale, keeping for sale, bartering, or furnishing of a controlled
- 5 substance.
- 6 (d) It is used for the unlawful manufacture, transporting,
- 7 sale, keeping for sale, bartering, or furnishing of vinous, malt,
- 8 brewed, fermented, spirituous, or intoxicating liquors or mixed
- 9 liquors or beverages, any part of which is intoxicating.
- 10 (e) It is used for conduct prohibited by section 49 of the
- 11 Michigan penal code, 1931 PA 328, MCL 750.49.
- 12 (f) It is used for conduct prohibited by chapter LXVIIA of the
- 13 Michigan penal code, 1931 PA 328, MCL 750.462a to 750.462h.
- 14 (g) It is used to facilitate armed violence in connection with
- 15 the unlawful use of a firearm or other dangerous weapon.
- 16 (2) All furniture, fixtures, and contents of a building,
- 17 vehicle, boat, aircraft, or place described in subsection (1) and
- 18 all intoxicating liquors in the building, vehicle, boat, aircraft,
- 19 or place are also declared a nuisance.
- 20 (3) All controlled substances and nuisances shall must be
- 21 enjoined and abated as provided in this act and the court rules.
- 22 (4) A person, or a servant, agent, or employee of the person,
- 23 who owns, leases, conducts, or maintains a building, vehicle, or
- 24 place described in subsection (1) is guilty of a nuisance.
- 25 (5) As used in this section, "controlled substance" means that
- 26 term as defined in section 7104 of the public health code, 1978 PA
- 27 368, MCL 333.7104.
- 28 Enacting section 1. This amendatory act takes effect 90 days
- 29 after the date it is enacted into law.
