THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER LXVII 2 PROSTITUTION COMMERCIAL SEXUAL ACTIVITY 3 Sec. 448. A person 16 years of age or older who accosts, 4 solicits, or invites another person in a public place or in or from 5 a building or vehicle, by word, gesture, or any other means, to 6 commit prostitution or to do any other lewd or immoral act, is 7 quilty of a crime punishable as provided in section 451. As used in 8 this chapter, "commercial sexual activity" means that term as 9 defined in section 462a. 10 Sec. 449. (1) A Except as provided in subsection (2), a person 11 16 years of age or older who receives or admits or offers to 12 receive or admit a person into a place, structure, house, building, 13 or vehicle for the purpose of prostitution, lewdness, or assignation, or who knowingly permits a person to remain in a 14 place, structure, house, building, or vehicle for the purpose of 15 prostitution, lewdness, or assignation, provides or offers to 16 17 provide a commercial sexual activity is quilty of a crime 18 punishable as provided in section 451. 19 (2) If the person's actions that violated subsection (1) were 20 a direct result of being a victim of human trafficking under 21 chapter LXVIIA or if the person's actions were caused, induced, 22 persuaded, encouraged, or enticed by a promise or threat, violence, 23 or any device or scheme in violation of section 455 the person must 24 be assessed for a deferral under section 451c. 25 Sec. 450. (1) A person 16 years of age or older who aids, 26 assists, or abets another person to commit or offer to commit an

- 1 act prohibited under section 448, 449, or 449a is quilty of a crime
- 2 punishable as provided in section 451. Except as provided in
- 3 subsection (2), a person who obtains or offers to obtain a
- 4 commercial sexual activity is guilty of a crime punishable as
- 5 provided in section 451. A person who is convicted of violating
- 6 this section is subject to part 52 of the public health code, 1978
- 7 PA 368, MCL 333.5201 to 333.5210.
- 8 (2) A person who obtains or offers to obtain commercial sexual
- 9 activity from a person who is less than 18 years of age is guilty
- 10 of a crime punishable as provided in section 451.
- 11 Sec. 452. A person who keeps, maintains, or operates, or aids
- 12 and abets in keeping, maintaining, or operating, a house of ill-
- 13 fame, bawdy house, or any house or other place resorted to for the
- 14 purpose of prostitution or lewdness commercial sexual activity is
- 15 guilty of a felony punishable by imprisonment for not more than 5
- 16 years or by a fine of not more than \$5,000.00, or both.
- 17 Sec. 454. Any person who shall let any dwelling rents a house,
- 18 room, or vehicle knowing that the lessee person to whom the house,
- 19 room, or vehicle is rented intends to use it as a house of ill-fame
- 20 or place of resort for the purpose of prostitution and lewdness, or
- 21 for the purpose of gambling for money or other property, for
- 22 commercial sexual activity, or who shall knowingly permit such
- 23 lessee to use the same for such purpose, permits the person to whom
- 24 the house, room, or vehicle was rented to use the house, room, or
- 25 vehicle for commercial sexual activity, or who shall receive any
- 26 receives rent or any other consideration for any dwelling, house,
- 27 room, or apartment which is vehicle that is used as a house of ill-
- 28 fame or place of resort for prostitutes, or for the purpose of
- 29 prostitution and lewdness, or for the purpose of gambling for money

- Sec. 455. A person who does any of the following is guilty of a felony punishable by imprisonment for not more than 20 years:
- 12 (a) Procures an inmate for a house of prostitution.occupant
- 13 for a house, vehicle, or other place in which commercial sexual
- 14 activity is practiced, encouraged, or allowed.
- 15 (b) Induces, persuades, encourages, inveigles, or entices a
- 16 person to become a prostitute.provider of commercial sexual
- 17 activity.
- 18 (c) By promise, threat, or violence, or by any device or
- 19 scheme, causes, induces, persuades, encourages, takes, places,
- 20 harbors, inveigles, or entices a person to become an inmate of a
- 21 house, of prostitution or assignation place vehicle, or any other
- 22 place where prostitution in which commercial sexual activity is
- 23 practiced, encouraged, or allowed.
- 24 (d) By any promise or threat, or by violence or any device or
- 25 scheme, causes, induces, persuades, encourages, inveigles, or
- 26 entices an inmate occupant of a house, of prostitution vehicle, or
- 27 other place of assignation in which commercial sexual activity is
- 28 practiced, encouraged, or allowed to remain there as an inmate.

1 (e) By any promise or threat, or by violence, any device or scheme, fraud or artifice, or by duress of person or goods, or by abuse of any position of confidence or authority, or having legal charge, takes, places, harbors, inveigles, entices, persuades, encourages, or procures any person to engage in prostitution.

- (f) Inveigles, entices, Entices, persuades, encourages, or procures any person to come into this state or to leave this state for the purpose of prostitution.providing commercial sexual activity.
- (g) Upon the pretense of marriage, takes or detains a personfor the purpose of sexual intercourse.
- (h) Receives or gives, or agrees to receive or give, any money or thing of value for procuring or attempting to procure any person to become a prostitute provide commercial sexual activity or to come into this state or leave this state for the purpose of prostitution.a commercial sexual activity.
 - Sec. 456. Any person who by force, fraud, intimidation, or threat places or leaves, or procures any other person to place or leave, his or her spouse in a house, of prostitution or to lead a life of prostitution, vehicle, or other place in which commercial sexual activity is practiced, encouraged, or allowed or to provide commercial sexual activity is guilty of a felony punishable by imprisonment for not more than 20 years.
- Sec. 457. (1) Any person who knowingly accepts, receives, levies, or appropriates any money or valuable thing without consideration from the proceeds of the earnings of any person engaged in prostitution, providing commercial sexual activity, or any person, knowing a person to be a prostitute, providing

- 1 commercial sexual activity, who lives or derives support or
- 2 maintenance, in whole or in part, from the earnings or proceeds of
- 3 the prostitution of a prostitute, person providing commercial
- 4 sexual activity, or from money loaned or advanced to or charged
- 5 against a prostitute person providing commercial sexual activity by
- 6 any keeper or manager or inmate occupant of a house, vehicle, or
- 7 other place where prostitution in which commercial sexual activity
- 8 is practiced, encouraged, or allowed, is quilty of a felony
- 9 punishable by imprisonment for not more than 20 years.
- 10 (2) The acceptance, receipt, levy, or appropriation of money 11 or any thing of value described in subsection (1) is presumptive
- 12 evidence of lack of consideration.
- Sec. 458. Any person who attempts to detain any another person
- 14 in a disorderly house, vehicle, or house of prostitution other
- 15 place in which commercial sexual activity is practiced, encouraged,
- or allowed because of any a debt or debts the other person has
- 17 contracted, or is said to have contracted while living in that
- 18 house, there is guilty of a felony punishable by imprisonment for
- 19 not less than 2 years or more than 20 years.
- Sec. 459. (1) A person shall not knowingly transport or cause
- 21 to be transported, or aid or assist in obtaining transportation
- 22 for, by any means of conveyance, into, through, or across this
- 23 state, any person for the purpose of prostitution commercial sexual
- 24 activity or with the intent and purpose to induce, entice, or
- 25 compel that person to become a prostitute. provider of commercial
- 26 sexual activity. A person who violates this subsection is quilty of
- 27 a felony punishable by imprisonment for not more than 20 years or a
- 28 fine of not more than \$20,000.00, or both.
- 29 (2) A person shall not knowingly sell or offer to sell travel

- 1 services that include or facilitate travel for the purpose of
- 2 engaging in what conduct that would be a violation of this chapter,
- 3 concerning prostitution, commercial sexual activity, or of chapter
- 4 LXVIIA, concerning human trafficking, if the violation occurred in
- 5 this state. Except as provided in subsection (3), a person who
- 6 violates this subsection is guilty of a felony punishable by
- 7 imprisonment for not more than 5 years or a fine of not more than
- **8** \$10,000.00, or both.
- 9 (3) If a person violates subsection (2) and the violation
- 10 involves conduct against a minor, the person is guilty of a felony
- 11 punishable by imprisonment for not more than 10 years or a fine of
- 12 not more than \$15,000.00, or both.
- 13 (4) A person who violates this section may be prosecuted,
- 14 indicted, tried, and convicted in any county or city in or through
- 15 which he or she shall transport transports or attempt attempts to
- 16 transport any another person in violation of this section.
- 17 (5) As used in this section, "travel services" means
- 18 transportation by air, sea, or ground, hotel or other lodging
- 19 accommodations, package tours, or the provision of vouchers or
- 20 coupons to be redeemed for future travel, or accommodations for a
- 21 fee, commission, or other valuable consideration.
- 22 Sec. 460. (1) It is not a defense to a prosecution for a
- 23 violation of this chapter that any part of that violation was
- 24 committed outside this state.
- 25 (2) A person who violates this chapter may be tried and
- 26 punished in any county in which the prostitution commercial sexual
- 27 activity was intended to be practiced, or in which the offense was
- 28 consummated, provided or obtained, or in which any overt act in
- 29 furtherance of the offense was committed.

- 1 Sec. 462. A person who, for a purpose other than prostitution,
- 2 commercial sexual activity, takes or conveys to, or employs,
- 3 receives, detains, or allows a person 16 years of age or less to
- 4 remain in, a house, of prostitution, house of ill-fame, bawdy-
- 5 house, house of assignation, or any house vehicle, or other place
- 6 for the resort of prostitutes or other disorderly persons in which
- 7 commercial sexual activity is practiced, encouraged, or allowed is
- 8 quilty of a crime punishable as provided in section 451.
- 9 Enacting section 1. Section 449a of the Michigan penal code,
- 10 1931 PA 328, MCL 750.449a, is repealed.
- 11 Enacting section 2. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
