HOUSE BILL NO. 4199

February 10, 2021, Introduced by Rep. Hornberger and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1284a (MCL 380.1284a), as added by 2007 PA 101; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1284a. (1) Not later than July 1, 2008, an An
- 2 intermediate school district, in cooperation with its constituent
- 3 districts, shall adopt a common school calendar to apply to all of
- 4 its constituent districts and to its intermediate school district

- 1 programs. The intermediate school district shall post the common
- 2 school calendar on its website. The common school calendar shall

- 4 (a) Shall Must be in compliance with sections 1284 and 1284b.section 1284.
- 6 (b) Shall Must identify the dates for each school year when
 7 school will not be in session for a winter holiday break and a
 8 spring break. The common school calendar shall must identify these
 9 dates specifically for at least the next 5 school years, but may
 10 describe these dates more generally for school years thereafter as
 11 long as the dates may be readily determined.
 - (2) Beginning with the 2008-2009 school year, except Except as otherwise provided in this section, the board of each constituent district and the intermediate school board shall ensure that its school calendar complies with the common school calendar adopted under subsection (1).
- 17 (3) In addition to the requirements under subsection (1), a
 18 common school calendar adopted under subsection (1) is encouraged
 19 to identify common dates for professional development days.
 - (4) If a collective bargaining agreement that provides a complete school calendar is in effect for employees of a school district or intermediate school district as of the effective date of this section, and if that school calendar is not in compliance with the common school calendar adopted under subsection (1), then subsection (2) does not apply to that school district or intermediate school district until after the expiration of that collective bargaining agreement.
- (4) (5) If as of the effective date of this section October 1,

- 13 operates all of grades 6 to 12 at a single site, that aligns its
- 14 high school curriculum with advanced placement courses as the
- 15 capstone of the curriculum, and that ends its second academic
- 16 semester concurrently with the end of the advanced placement
- 17 examination period.
- 18 (7) (8) In addition to the other exceptions under this
- 19 section, the superintendent of public instruction may grant a
- 20 waiver from a requirement under this section for a school district
- 21 that applies for the waiver in writing in the form and manner
- 22 prescribed by the superintendent of public instruction and provides
- 23 sufficient justification for the waiver, as determined by the
- 24 superintendent of public instruction.
- 25 (8) $\frac{(9)}{}$ As used in this section:
- 26 (a) "Board" means the board of a school district or board of
- 27 directors of a public school academy.
- 28 (b) "Constituent district" means a constituent district of the
- 29 intermediate school district or a public school academy that is

- 1 located within the boundaries of the intermediate school district
- 2 and that receives services from the intermediate school district.
- 3 (c) "School district" means a school district or a public
- 4 school academy.
- 5 Enacting section 1. Section 1284b of the revised school code,
- 6 1976 PA 451, MCL 380.1284b, is repealed.
- 7 Enacting section 2. Section 160 of the state school aid act of
- 8 1979, 1979 PA 94, MCL 388.1760, is repealed.
- **9** Enacting section 3. This amendatory act takes effect 90 days
- 10 after the date it is enacted into law.
