THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 4jj. (1) A person subject to the tax under this act may exclude from the gross proceeds used for the computation of the tax the sale of eligible broadband equipment and installation materials to a qualified business for installation in an unserved area in

- 8 (a) "Affiliate" means that term as defined in section 4ee.
- 9 (b) "Broadband service" means a retail terrestrial service
 10 capable of delivering high-speed internet access at speeds of at
 11 least 10 megabits per second downstream and 1 megabit per second
 12 upstream.
- 13 (c) "Census block" means a geographic area defined as a census 14 block by the United States Department of Commerce, Bureau of the 15 Census in conducting the most recent decennial census.
- 16 (d) "Eligible broadband equipment" means any equipment that is 17 used for or is substantially related to providing broadband service 18 in at least 1 direction. Eligible broadband equipment includes, but 19 is not limited to, asynchronous transfer mode switches, digital 20 subscriber line access multiplexers, antennas, routers, servers, 21 multiplexers, fiber optic cable, and related equipment technology. 22 Eligible broadband equipment also includes, but is not limited to, 23 the following:
 - (i) For a qualified business that is a telecommunications carrier, equipment that is necessary to provide broadband service and is an integral part of a broadband network.
- (ii) For a qualified business that is a commercial mobile service carrier, equipment extending from the subscriber side of the mobile telecommunications switch to a transmitting or receiving

- 1 antenna, including the antenna, on the outside of the structure in 2 which the subscriber is located.
- 3 (iii) For a qualified business that is a cable or open video
 4 system operator or video service provider, equipment extending from
 5 within the headend to the outside of the structure in which the
 6 subscriber is located.
- 7 (e) "Installation materials" means materials used or consumed 8 in the installation of eligible broadband equipment, including, but 9 not limited to, mounting hardware, poles, conduits, and ducts.
- 10 (f) "Qualified business" means a person that provides, whether 11 directly or indirectly through 1 or more affiliates, broadband 12 service, including wireless broadband service.
- 13 (g) "Unserved area" means either a census block without at
 14 least 1 provider providing broadband service within the census
 15 block, or a specific area within a census block in which no
 16 provider is providing broadband service.
