A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 48729 (MCL 324.48729), as amended by 2018 PA 643.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 48729. (1) Except as otherwise provided in subsection
- 2 (2), a person shall not do any of the following:
- 3 (a) Take or possess minnows, wigglers, or crayfish for
- 4 commercial purposes from any of the waters over which this state

- 1 has jurisdiction; import minnows, wigglers, or cravfish for
- 2 commercial purposes from outside of this state; or transport
- 3 minnows, wigglers, or crayfish without having first procured a
- 4 license as provided in section 48732. A license, except a license
- 5 to fish in the waters of this state as provided in part 435, is not
- 6 required of persons taking minnows, wigglers, or crayfish for their
- 7 individual use for bait. A person shall not set or use minnow traps
- 8 for the taking of minnows, wigglers, or crayfish for any purpose
- 9 unless the name and address of the user is on the trap.
- 10 (b) Export out of this state any minnows, wigglers, or
- 11 crayfish, dead or alive, taken either in or outside of this state
- 12 unless that person holds a permit issued under this subdivision.
- 13 The department, upon receipt of a payment of \$25.00, may issue a
- 14 permit, revocable by the department, under any regulations the
- 15 department prescribes, to any resident licensed as provided for in
- 16 section 48732, enabling that person to transport outside of this
- 17 state minnows, wigglers, or crayfish. that were harvested from
- 18 waters outside of this state's jurisdictional border and imported
- 19 wholesale across that border. Minnows, wigglers, and crayfish taken
- 20 from waters over which this state has jurisdiction may not be
- 21 exported from this state. Imported wholesale minnows, wigglers, and
- 22 crayfish must be held separately from any minnows, wigglers, or
- 23 crayfish taken from waters over which this state has jurisdiction.
- 24 A person holding a permit as provided in this subdivision and
- 25 transporting wholesale minnows, wigglers, or crayfish shall produce
- 26 documentation that contains the origin of the shipment,
- 27 registration or permit copies, documentation demonstrating the
- 28 shipment's destination, and any other proof required by the
- 29 department, upon demand of the director or a law enforcement

- 1 officer. The department may revoke a permit issued under this
- 2 subdivision upon good cause. A permit issued under this subdivision
- 3 expires on December 31 following the date the license is issued

- 23 the wholesale or retail establishment the minnows, wigglers, or
- 24 crayfish were purchased from and must possess and present that
- 25 receipt upon request of a peace officer until the minnows,
- 26 wigglers, or crayfish are no longer in possession of that person. A
- 27 person who operates as a charter fishing guide may not sell or
- 28 furnish minnows, wigglers, or crayfish for any other purpose
- 29 outside the context described in this subsection without having
