A bill to amend 1976 PA 399, entitled

"Safe drinking water act,"

by amending section 2 (MCL 325.1002), as amended by 1998 PA 56, and by adding section 7a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Bottled drinking water" means water that is ultimately
- 3 sold, provided, or offered for human consumption in a closed

- 1 container.
- 2 (b) "Capacity assessment" means an evaluation of the
- 3 technical, financial, and managerial capability of a community
- 4 supply or nontransient noncommunity water supply to comply and
- 5 maintain compliance with all requirements of this act and the rules
- 6 promulgated under this act.
- 7 (c) "Child care center" means that term as defined in section
- 8 1 of 1973 PA 116, MCL 722.111.
- 9 (d) (c) "Community supply" means a public water supply that
- 10 provides year-round service to not no fewer than 15 living units or
- 11 which that regularly provides year-round service to not no fewer
- 12 than 25 residents.
- (e) (d) "Contaminant" means a physical, chemical, biological,
- 14 or radiological substance or matter in water.
- (f) (e) "Customer service connection" means the pipe between a
- 16 water main and customer site piping or building plumbing system.
- 17 (g) (f) "Customer site piping" means an underground piping
- 18 system owned or controlled by the customer that conveys water from
- 19 the customer service connection to building plumbing systems and
- 20 other points of use on lands owned or controlled by the customer.
- 21 Customer site piping does not include any system that incorporates
- 22 treatment to protect public health.
- (h) (g) "Department" means the department of environmental
- 24 quality environment, Great Lakes, and energy or its authorized
- 25 agent or representative.
- 26 (i) (h)—"Director" means the director of the department of
- 27 environmental quality or his or her authorized agent or
- 28 representative.
- 29 (j) (i) "Imminent hazard" means a condition that, in the

- 1 judgment of the director, there is a violation, or a condition that
- 2 is or may cause a violation —of the state drinking water standards
- 3 at a public water supply requiring immediate action to prevent
- 4 endangering the **public** health. of people.
- (k) (j) "Living unit" means a house, apartment, or other
 domicile occupied or intended to be occupied on a day to day basis
- 7 by an individual, family group, or equivalent.
- 8 (1) (k) "Noncommunity supply" means a public water supply that
- 9 is not a community supply, but that has not less no fewer than 15
- 10 service connections or that serves not no fewer than 25 individuals
- 11 on an average daily basis for not less no fewer than 60 days per
- **12** year.
- (m) (l) "Nontransient noncommunity water supply" means a
- 14 noncommunity public water supply that serves not no fewer than 25
- 15 of the same individuals on an average daily basis over 6 months per
- 16 year. This definition Nontransient noncommunity water supply
- 17 includes water supplies in places of employment, schools, and day-
- 18 care child care centers.
- (n) (m) "Person" means an individual, partnership,
- 20 copartnership, cooperative, firm, company, public or private
- 21 association or corporation, political subdivision, agency of the
- 22 this state, agency of the federal government, trust, estate, joint
- 23 structure company, or any other legal entity, or their the legal
- 24 representative, agent, or assigns assign of a legal entity.
- 25 (o) (n) "Plans and specifications" means drawings, data, and a
- 26 true description or representation of an entire waterworks system
- 27 or parts of the system as it exists or is to be constructed, and a
- 28 statement on how a the waterworks system is to will be operated.
- (p) (o) "Political subdivision" means a city, village,

- 1 township, charter township, county, district, authority, or portion
 2 or combination thereof.of those entities.
- 3 (q) (p) "Public water supply" means a waterworks system that
 4 provides water for drinking or household purposes to persons other
 5 than the supplier of the water, and does not include either of the
 6 following:
- 7 (i) A waterworks system that supplies water to only 1 living unit.
- $\mathbf{9}$ (ii) A waterworks system that consists solely of customer site $\mathbf{10}$ piping.
- 15 (r) "School" means a public school or nonpublic school as 16 those terms are defined in section 5 of the revised school code, 17 1976 PA 451, MCL 380.5.
- (s) (r) "Service connection" means a direct connection from a
 distribution water main to a living unit or other site to provide
 water for drinking or household purposes.
- 21 (t) (s)—"Source water assessment" means a state program to
 22 delineate—that does all of the following:
- (ii) Identifies contaminants regulated under this act for which
 monitoring is required because the this state has determined that
 they may present a threat to the public health. 7 and, to
- 29 (iii) To the extent practical, to determine determines the

- susceptibility of the public water supply in the delineated area to
 these contaminants.
- 3 (u) "State drinking water standards" means quality standards
 4 setting limits for contaminant levels or establishing treatment
 5 techniques to meet standards necessary to protect the public
 6 health.
- 7 (v) (t) "Supplier of water" or "supplier" means a person who
 8 that owns or operates a public water supply, and includes a water
 9 hauler.
- 10 (w) (u) "Transient noncommunity water supply" means a
 11 noncommunity supply that does not meet the definition of
 12 nontransient noncommunity water supply.

- (x) (v) "Water hauler" means a person engaged in bulk vehicular transportation of water to other than the water hauler's own household which and that is intended for use or used for drinking or household purposes. Excluded from this definition are those persons providing Water hauler does not include a person that provides water solely for employee use.
- (y) (w) "Water main" means a pipe owned or controlled by a supplier that may convey water to a customer service connection or to a fire hydrant.
- (z) (x)—"Waterworks system" or "system" means a system of pipes and structures through which water is obtained and distributed, including but not limited to wells and well structures, intakes and cribs, pumping stations, treatment plants, storage tanks, and pipelines and appurtenances, or a combination thereof, of these components, actually used or intended for use for the purpose of furnishing water for drinking or household purposes.
- 29 (aa) (y) "Year-round service" means the ability of a supplier

- 1 of water to provide drinking water on a continuous basis to a
- 2 living unit or facility.
- 3 Sec. 7a. (1) The department shall establish a program to
- 4 assist schools and child care centers in testing and remedying lead
- 5 contamination in drinking water from drinking water coolers or
- 6 other sources under the control of the schools or child care
- 7 centers. The program must require that the school or child care
- 8 center repair, replace, remove, or render inoperable a drinking
- 9 water cooler that is a source of lead contamination.
- 10 (2) Each school or child care center shall conduct periodic
- 11 sampling and testing of the drinking water at the school or child
- 12 care center for the presence of lead and report the test results to
- 13 the department.
