## **HOUSE BILL NO. 4531**

March 17, 2021, Introduced by Reps. Filler, Calley and Whitsett and referred to the Committee on Elections and Ethics.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 702 and 703 (MCL 380.702 and 380.703), as amended by 2003 PA 299.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 702. (1) An intermediate school district may be annexed 1
- 2 to another intermediate school district if the intermediate school board of the annexing intermediate school district approves the
- 4 annexation by resolution, and a majority of the school electors of

- 1 the intermediate school district to be annexed voting on the
- 2 question at a regular or special school election in the
- 3 intermediate school district approve the annexation. If prior to
- 4 before annexation the annexing intermediate school district adopts
- 5 a special education program by referendum as provided in part 30,
- 6 the intermediate school electors of the intermediate school
- 7 district to be annexed must vote to adopt that special education
- 8 program and annual tax rate. The vote on the question shall must be
- 9 by ballot furnished by the school district filing official for the
- 10 intermediate school district to be annexed. Before the election is
- 11 held, the annexing intermediate school board shall must obtain the
- 12 approval of the superintendent of public instruction of the
- 13 proposed annexation.
- 14 (2) Within 10 days after the election, the school district
- 15 filing official shall file the result with the secretary of the
- 16 intermediate school board, and 5 days later the intermediate school
- 17 board secretary shall file the election result with the secretary
- 18 of the intermediate school board of the annexing intermediate
- 19 school district. Within 15 days after the annexation election the
- 20 intermediate school board of the annexed intermediate school
- 21 district shall account to the intermediate school board of the
- 22 annexing intermediate school district for the money and property in
- 23 its hands and shall turn over the money and property to that
- 24 intermediate school board. Property and money belonging to the
- 25 annexed intermediate school district becomes the property of the
- 26 annexing intermediate school district. The outstanding indebtedness
- 27 of the annexed intermediate school district becomes the liability
- 28 of the annexing intermediate school district. Upon receipt of the
- 29 money and property, the members of the annexed intermediate school

- board shall be released from liability for the money and property
  and their offices terminated.
- 3 (3) The annexation is effective on the latest date on which
- 4 the election was held in a constituent district of the annexed
- 5 intermediate school district. The secretary of the intermediate
- 6 school board of the annexing intermediate school district shall
- 7 give written notice of the annexation to the superintendent of
- 8 public instruction within 15 days after the annexation election.
- 9 Within 30 days after annexation, the board of the annexing
- 10 intermediate school district shall appoint 2 school electors of the
- 11 annexed intermediate school district to membership on the
- 12 intermediate school board of the reorganized intermediate school
- 13 district, who shall serve until January 1. or, if the intermediate
- 14 school district's regular school election is held in May, until
- 15 July 1 after the next intermediate school district election.
- 16 Notification of the appointments shall must be filed with the
- 17 superintendent of public instruction. If the appointments are not
- 18 made within the 30 days, the superintendent of public instruction
- 19 shall make the appointments. At the next intermediate school
- 20 district election, members of the intermediate school board shall
- 21 be elected in the number and for the terms required in section 701.
- 22 The terms of the members of the intermediate school board whose
- 23 terms have not expired shall determine the terms of the additional
- 24 members to be elected.
- 25 Sec. 703. (1) An intermediate school district comprised of
- 26 less than 5 constituent districts and having no bonded indebtedness
- 27 may be disorganized and its constituent districts attached to
- 28 contiguous intermediate school districts under this section.
- 29 (2) The board of each constituent district may request the

- 1 intermediate school board to prescribe a plan for disorganization
- 2 of the intermediate school district. Each request shall must
- 3 designate another intermediate school district to which the
- 4 constituent district desires to be attached. The intermediate
- 5 school board shall prescribe, by resolution, a plan under which
- 6 each of the constituent districts will be attached in whole to
- 7 contiguous intermediate school districts designated in the
- 8 requests. If the designated intermediate school district is not
- 9 contiguous, the intermediate school board's plan may prescribe
- 10 attachment to a contiguous intermediate school district.
- 11 (3) The intermediate superintendent of the intermediate school
- 12 district that is to be disorganized shall give 30 days' notice of
- 13 the time and place of the meeting of the intermediate school board
- 14 and of the proposed plan for disorganization by publication of the
- 15 notice in a newspaper of general circulation in the intermediate
- 16 school district. The intermediate school board shall present the
- 17 adopted plan for dissolution to the board of each of its
- 18 constituent districts and to the intermediate school board of each
- 19 intermediate school district whose boundaries would be enlarged by
- 20 the proposal.
- 21 (4) The intermediate superintendent of each intermediate
- 22 school district whose boundaries would be enlarged by the
- 23 dissolution shall give 30 days' notice of the time and place of the
- 24 meeting of the intermediate school board and of the recommended
- 25 plan for enlargement of the intermediate school district by
- 26 publication of the notice in a newspaper of general circulation in
- 27 the intermediate school district.
- 28 (5) If the intermediate school board of each affected
- 29 intermediate school district approves the plan for disorganization,

- 1 the intermediate school board of the intermediate school district
- 2 to be dissolved shall refer the matter to the superintendent of
- 3 public instruction for approval. The action of the superintendent
- 4 of public instruction declaring the intermediate school district
- 5 dissolved is final. Disorganization of the intermediate school
- 6 district and attachment of its constituent districts to contiquous
- 7 intermediate school districts takes effect on July 1 after the date
- 8 of the approval of the superintendent of public instruction.
- 9 (6) The intermediate school boards of the intermediate school
- 10 districts to which territory is attached by dissolution shall meet
- 11 jointly, sitting as a single board, and make an equitable
- 12 distribution of the money, property, and other assets belonging to
- 13 the disorganized intermediate school district among the
- 14 intermediate school districts affected. The territory of
- 15 constituent districts transferred to other intermediate school
- 16 districts by dissolution shall be are subject to all taxes levied
- 17 for purposes of the intermediate school district to which
- 18 transferred, including taxes for the retirement of bonded
- 19 indebtedness, special education programs, and area vocational-
- 20 technical education programs.
- 21 (7) Within 30 days after a district attaches to a contiguous
- 22 intermediate school district under this section, the board of the
- 23 intermediate school district whose boundaries have been enlarged by
- 24 the dissolution may appoint 2 school electors of constituent
- 25 districts, 1 of whom shall be an elector of the attached district,
- 26 to membership on the intermediate school board. Intermediate school
- 27 board members appointed under this subsection serve until January
- 28 1. or, if the intermediate school district's regular school
- 29 election is held in May, until July 1 after the next intermediate

- 1 school district election. The intermediate school board may
- 2 determine 1 initial term of less than 6 years for 1 of the
- 3 additional members to be elected at the intermediate school
- 4 district election. Notification of an appointment shall must be
- 5 filed with the superintendent of public instruction.
- 6 Enacting section 1. This amendatory act does not take effect
- 7 unless Senate Bill No. or House Bill No. 4530 (request no.
- 8 02140'21) of the 101st Legislature is enacted into law.
