## **HOUSE BILL NO. 4540**

March 18, 2021, Introduced by Reps. Tyrone Carter, Filler, Tate and Scott and referred to the Committee on Government Operations.

A bill to amend 1965 PA 203, entitled "Michigan commission on law enforcement standards act," by amending section 2 (MCL 28.602), as amended by 2016 PA 289.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
