## **HOUSE BILL NO. 4668**

April 20, 2021, Introduced by Rep. Brann and referred to the Committee on Regulatory Reform.

A bill to amend 1980 PA 497, entitled "Construction lien act,"

by amending section 114 (MCL 570.1114), as amended by 2016 PA 415.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 114. (1) A contractor does not have a right to a
- 2 construction lien on the interest of an owner or lessee in a
- 3 residential structure unless the contractor has provided an
- 4 improvement to the residential structure under a written contract
- 5 between the owner or lessee and the contractor and any amendments

- 1 or additions to the contract are also in writing. The contract
- 2 required under this section shall must contain a statement, in type
- 3 no smaller than that of the body of the contract, stating all of
- 4 the following:
- 5 (a) That a residential builder or a residential maintenance

- 7 24 of the occupational code, 1980 PA 299, MCL 339.2401 to 339.2412.
- 8 That an electrician is required to be licensed under article 7 of
- 9 the skilled trades regulation act, 2016 PA 407, MCL 339.5701 to
- 10 339.5739. That a plumbing contractor is required to be licensed
- 11 under article 11 of the skilled trades regulation act, 2016 PA 407,

- 15 (b) If the contractor is required to be licensed to provide

- 19 in this section, shall display the contractor's license and, if the
- 20 contractor is an individual, the contractor's personal
- 21 identification when recording a claim of lien under section 111. If

- 23 attach to the claim of lien copies of the contractor's license and

- 1 identification to the claim of lien, as required by subsection (2).
- 2 (4) A contractor who violates this section is guilty of a
- 3 misdemeanor punishable by imprisonment for not more than 90 days or
- 4 a fine of not more than \$500.00, or both.
- 5 (5) As used in this section, "personal identification" means
- 6 an operator's license, chauffeur's license, enhanced driver
- 7 license, official state personal identification card, or enhanced
- 8 official state personal identification card issued by this state.
- 9 Enacting section 1. This amendatory act takes effect 90 days
- 10 after the date it is enacted into law.
