

# HOUSE BILL NO. 4721

April 27, 2021, Introduced by Reps. Hood, Tyrone Carter, Steckloff, Hope, Brixie, LaGrand, Kupa, Pohutsky, Neeley, Cynthia Johnson, Aiyash, Young, Garza, Anthony, Ellison, Brenda Carter, Peterson, Lasinski, Stone, Hertel, Sowerby, Bolden, Weiss, Whitsett and Yancey and referred to the Committee on Government Operations.

A bill to amend 2013 PA 240, entitled  
"Michigan state capitol historic site act,"  
by amending section 6 (MCL 4.1946).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

- 1           Sec. 6. (1) The commission shall do all of the following:
- 2           (a) Subject to subsection (2), operate and manage the Michigan
- 3 state capitol historic site.
- 4           (b) Maintain and restore the state capitol building.
- 5           (c) Maintain and improve the grounds of the Michigan state

1 capitol historic site.

2 (d) Appoint an individual to manage the day-to-day operations  
3 of the Michigan state capitol historic site. The individual  
4 appointed under this subdivision is an at-will employee and shall  
5 serve at the pleasure of the commission.

6 (e) Employ staff to carry out the commission's  
7 responsibilities under subsection (1) and as otherwise provided by  
8 law. All individuals employed by the commission are nontenured, at-  
9 will employees. The commission may discipline, transfer, demote,  
10 suspend, or summarily discharge an employee.

11 (f) Contract with any person for purposes of procuring goods  
12 or services or otherwise carrying out the commission's  
13 responsibilities with regard to the Michigan state capitol historic  
14 site.

15 (g) Make recommendations to the governor, the senate, and the  
16 house of representatives regarding funding for the Michigan state  
17 capitol historic site, including, but not limited to, funding from  
18 the fund.

19 **(h) By March 1, 2021, enter into a contract with a third party**  
20 **for a safety study for the Michigan state capitol historic site.**  
21 **The study must include all of the following:**

22 **(i) An evaluation of the current safety measures for the**  
23 **Michigan state capitol historic site.**

24 **(ii) Safety recommendations for the Michigan state capitol**  
25 **historic site.**

26 **(iii) Crime prevention recommendations for the Michigan state**  
27 **capitol historic site.**

28 **(i) ~~(h)~~ Carry out other responsibilities as provided by law.**

29 **(2) The commission does not have authority and shall not**

1 exercise control over the internal decisions of the senate or the  
2 house of representatives related to the allocation of space in the  
3 state capitol building or the state capitol building parking lot,  
4 including legislative or staff offices. All decisions concerning  
5 space in the state capitol building and the state capitol building  
6 parking lot ~~shall~~**must** be made according to the rules or practices  
7 of the senate and the house of representatives.
