THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 3406d. (1) Subject to dollar limits, deductibles, and coinsurance provisions that are not less favorable than those for physical illness generally, an insurer that delivers, issues for delivery, or renews in this state a health insurance policy shall

- 4 (2) Subject to dollar limits, deductibles, and coinsurance

- 26 reconstructive plastic surgery, physical therapy, and psychological

- 29 view per breast, low-dose radiographic examination of the breasts,

- using equipment designed and dedicated specifically for
 mammography, in order to detect unsuspected breast cancer.
- 3 (d) "Breast cancer outpatient treatment services" means a
 4 procedure intended to treat cancer of the human breast, delivered
 5 on an outpatient basis, including but not limited to surgery,
 6 radiation therapy, chemotherapy, hormonal therapy, and related
 7 medical follow-up services.
