A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending section 2 (MCL 168.2), as amended by 2018 PA 603.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Absent voter" is a voter who utilizes the process
- **3** described in section 759.
- 4 (b) "Absent voter ballot" means a ballot that is issued to a
- 5 voter through the absentee voter process.

- 1 (c) "Ballot container" is defined in section 14a.
- 2 (d) "Business day" or "secular day" means a day that is not a
- 3 Saturday, Sunday, or legal holiday.
- 4 (e) "Clearly observable boundaries" is defined in section
- **5** 654a.
- 6 (f) "Common carrier" means a company that transports mail, on
- 7 reasonable request, on regular routes and at set rates.
- 8 (g) "Election" means an election or primary election at which
- 9 the electors of this state or of a subdivision of this state choose
- 10 or nominate by ballot an individual for public office or decide a
- 11 ballot question lawfully submitted to them.
- 12 (h) "Election precinct" is defined in section 654.
- (i) "Fall" state and county conventions and "spring" state and
- 14 county conventions are assigned meanings in section 596.
- 15 (j) "General election" or "general November election" means
- 16 the election held on the November regular election date in an even
- 17 numbered year.
- 18 (k) "Identification for election purposes" means, if issued to
- 19 the individual presenting the card or document and if presented for
- 20 voting purposes the name on the card or document sufficiently
- 21 matches the individual's name in his or her voter registration
- 22 record so as to accurately identify the individual as the
- 23 registered elector, or if issued to the individual presenting the
- 24 card or document and if presented for voter registration purposes,
- 25 any of the following:
- 26 (i) An operator's or chauffeur's license issued under the
- 27 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923, or an
- 28 enhanced driver license issued under the enhanced driver license
- 29 and enhanced official state personal identification card act, 2008

- 2 (ii) An official state personal identification card issued
- 3 under 1972 PA 222, MCL 28.291 to 28.300, or an enhanced official
- 4 state personal identification card issued under the enhanced driver
- 5 license and enhanced official state personal identification card
- 6 act, 2008 PA 23, MCL 28.301 to 28.308.
- 7 (iii) A current operator's or chauffeur's license issued by
- 8 another state.
- 9 (iv) A current state personal identification card issued by
- 10 another state.
- 11 (v) A current state government issued photo identification
- **12** card.
- 13 (vi) A current United States passport or federal government
- 14 issued photo identification card.
- 15 (vii) A current military photo identification card.
- 16 (viii) A current tribal photo identification card.
- 17 (ix) A current student photo identification card issued by a
- 18 high school in this state, an institution of higher education in
- 19 this state described in section 4, 5, or 6 of article VIII of the
- 20 state constitution of 1963, a junior college or community college
- 21 established under section 7 of article VIII of the state
- 22 constitution of 1963, or another accredited degree or certificate
- 23 granting college or university, junior college, or community
- 24 college located in this state.
- 25 (x) A current concealed pistol license issued under 1927 PA
- 26 372, MCL 28.421 to 28.435.
- 27 (1) "Immediate family" means an individual's father, mother,
- 28 son, daughter, brother, sister, and spouse and a relative of any
- 29 degree residing in the same household as that individual.
