A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

(MCL 722.111 to 722.128) by adding section 8e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 8e. (1) Within 90 days after the effective date of this
- 2 section, a child care center that is currently licensed and located

- 1 in a multiple occupancy building shall, in a form and manner as
- 2 prescribed by the department, notify the department if there has
- 3 been any change in occupancy or use by occupants within the
- 4 building since its license was issued. Beginning 90 days after the
- 5 effective date of this section, the department shall require each
- 6 applicant seeking licensure as a child care center within a
- 7 multiple occupancy building to clearly state on the application
- 8 that it will be located within a multiple occupancy building and
- 9 describe the nature and character of each of the other occupants
- 10 and the occupant use within that multiple occupancy building.
- 11 (2) Prior to issuing or renewing a license or provisional
- 12 license under this act to a child care center located within a
- 13 multiple occupancy building, the department shall inspect the
- 14 location to verify that the multiple occupancy and multiple use
- 15 site does not pose a serious risk to the health, safety, or well-
- 16 being of children who are under the care of the child care center.
- 17 As a condition of licensure for a child care center located within
- 18 a multiple occupancy building, the department may require the child
- 19 care center to do all of the following:
- 20 (a) Operate in a separate room, floor, or section of that
- 21 building.
- 22 (b) Have and utilize a separate entrance and bathroom facility
- 23 from the other occupants.
- 24 (c) Ensure that employees and children within the care of the
- 25 child care center do not share common areas, such as hallways,
- 26 gyms, or bathrooms, with other occupants of that building.
- 27 (d) If an outdoor area is available and shared, ensure that
- 28 there is a set schedule to keep the children separate from other
- 29 occupants of that building.

- 1 (e) Satisfy any other staffing, program, or operational
 2 requirements that the department determines are necessary to
 3 protect children within the care of that child care center from any
 4 serious risk of harm that may stem from being located within a
 5 multiple occupancy building.
- 6 (f) Require the licensee to notify the department within 90 7 days of a change of occupants or occupant use within that building.
- 8 (3) R 400.8560 of the Michigan Administrative Code is 9 rescinded.
