## **HOUSE BILL NO. 5268**

August 17, 2021, Introduced by Rep. Calley and referred to the Committee on Elections and Ethics.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 759. (1) Subject to **subsection (10) and** section 761(3), at any time during the 75 days before a primary or special primary, but not later than 8 p.m. on the day of a primary or special primary, an elector may apply for an absent voter ballot. The elector shall apply in person or by mail with the clerk of the township or city in which the elector is registered. The clerk of a

city or township shall not send by first-class mail an absent voter 1 ballot to an elector after 5 p.m. on the Friday immediately before 2 the election. Except as otherwise provided in section 761(2), the 3 clerk of a city or township shall not issue an absent voter ballot 4 to a registered elector in that city or township after 4 p.m. on 5 6 the day before the election. An application received before a 7 primary or special primary may be for either that primary only, or for that primary and the election that follows. An individual may 8 submit a voter registration application and an absent voter ballot 9 10 application at the same time if applying in person with the clerk 11 or deputy clerk of the city or township in which the individual resides. Immediately after his or her voter registration 12 application and absent voter ballot application are approved by the 13 14 clerk or deputy clerk, the individual may, subject to the 15 identification requirement in section 761(6), complete an absent 16 voter ballot at the clerk's office.

4 (6) The following instructions for an applicant for an absent
5 voter ballot must be included with each application furnished an
6 applicant:

INSTRUCTIONS FOR APPLICANTS FOR ABSENT VOTER BALLOTS

Step 1. After completely filling out the application, sign and date the application in the place designated. Your signature must appear on the application or you may not receive an absent voter ballot.

- Step 2. Deliver the application by 1 of the following methods:
- (a) Place the application in an envelope addressed to the appropriate clerk and place the necessary postage upon the return envelope and deposit it in the United States mail or with another public postal service, express mail service, parcel post service, or common carrier.
- (b) Deliver the application personally to the clerk's office, to the clerk, or to an authorized assistant of the clerk.
- (c) In either (a) or (b), a member of the immediate family of the voter including a father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law, grandparent, or grandchild or a person residing in the voter's household may mail or deliver the application to the clerk for the applicant.
- (d) If an applicant cannot return the application in any of the above methods, the applicant may select any registered elector to return the application. The person returning the application must sign and return the certificate at the bottom of the application.

- (7) A person who prints and distributes absent voter ballot applications shall print on the application the warning, certificate of authorized registered elector returning absent voter ballot application, and instructions required by this section.
- (8) A person who makes a false statement in an absent voter ballot application is guilty of a misdemeanor. A person who forges a signature on an absent voter ballot application is guilty of a felony. A person who is not authorized in this act and who both distributes absent voter ballot applications to absent voters and returns those absent voter ballot applications to a clerk or assistant of the clerk is guilty of a misdemeanor.
- (9) The absent voter ballot application of an elector who is a program participant, as that term is defined in **section 3 of** the address confidentiality program act, **2020 PA 301, MCL 780.853**, is confidential and not subject to disclosure under the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246.
- (10) Each county, city, and township clerk is prohibited from sending an absent voter ballot application to an elector unless the elector applies for an absent voter ballot as provided under subsection (1) or (2) or unless the elector has requested to be placed on a permanent absent voter application list maintained by a city or township clerk. The secretary of state is prohibited from sending an absent voter ballot application to an elector.
