A bill to amend 1979 PA 218, entitled "Adult foster care facility licensing act,"

by amending section 11 (MCL 400.711), as amended by 2016 PA 525.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) The director, the director's agent, or personnel
- 2 of another department or agency, acting at the request of the
- 3 director, may enter upon the premises of an applicant or licensee
- 4 at a reasonable time to make inspections, as permitted by
- 5 applicable law, to determine whether the applicant or licensee is

- 2 On-site inspections may be conducted without prior notice to the
- 3 adult foster care facility. A health and sanitation inspection of
- 4 an adult foster care facility shall be conducted upon the request

- 6 (a) Department staff.
 - (b) The department of health and human services.
- 8 (c) A local health department.
- 9 (2) The bureau of fire services created in section 1b of the
- 10 fire prevention code, 1941 PA 207, MCL 29.1b, or local authorities,
- 11 in carrying out this act, may visit an adult foster care facility

- 28 for the final determination of the issuance, denial, or revocation
- 29 and the temporary or provisional nature of a license issued to an

adult foster care facility. A report of the department's findings
shall must be furnished to the licensee or applicant.

- (7) The inspection reports required by this section shall be available for public inspection during reasonable business hours.
- (8) The department shall submit biannual reports to the appropriation subcommittees for the department, the senate and house fiscal agencies, and the state budget director containing inspector feedback and input from inspectors within the bureau of community and health systems regarding the adequacy of federal and state guidelines pertaining to entities regulated by the bureau of community and health systems.
