February 23, 2022, Introduced by Reps. Paquette and Albert and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

by amending sections 11 and 17b (MCL 388.1611 and 388.1617b), section 11 as amended by 2021 PA 48 and section 17b as amended by 2007 PA 137.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) For the fiscal year ending September 30, 2021,
- 2 there is appropriated for the public schools of this state and
- 3 certain other state purposes relating to education the sum of
- 4 \$13,715,807,900.00 from the state school aid fund, the sum of

- 5 emergency reserve fund. For the fiscal year ending September 30,

- 4 and the state budget director, may authorize an advance release of
- 5 funds due a district or intermediate district under this act. An
- 6 advance authorized under this subsection shall must not cause funds
- 7 to be paid to a district or intermediate district more than 30 days
- 8 earlier than the established payment date for those funds.
