

HOUSE BILL NO. 6054

April 27, 2022, Introduced by Reps. Koleszar, VanSingel, O'Malley, Puri, Breen and Brixie and referred to the Committee on Transportation.

A bill to establish an electric vehicle rebate program for residents of this state who purchase a new electric vehicle; to establish a process for the application and awarding of rebates; and to prescribe the powers and duties of certain state entities and officers.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. (1) Subject to an appropriation, the department shall
2 establish and implement an electric vehicle rebate program for
3 residents of this state who purchase a new electric vehicle after
4 October 1, 2022. The department shall develop an application

1 process for individuals to apply for rebates under this program. To
2 be eligible for a rebate under this program, the applicant must be
3 a resident of this state and must be the first title holder of the
4 new electric vehicle. The department may require applicants to
5 submit documentation with the application as necessary to determine
6 the eligibility for a rebate under this program.

7 (2) Subject to the limitations under this section, an
8 applicant who submits a completed application for the purchase of a
9 new electric vehicle within 120 days of making that purchase is
10 eligible to receive a rebate in an amount of not more than
11 \$2,000.00. Upon receipt of a completed application, the department
12 must determine eligibility of the applicant and, if eligible, issue
13 the rebate within a reasonable time.

14 (3) An applicant is limited to a rebate for the purchase of 1
15 new electric vehicle per calendar year.

16 Sec. 3. As used in this act:

17 (a) "All-electric vehicle" means a vehicle that runs on
18 electricity and is propelled by 1 or more electric motors powered
19 by rechargeable battery packs or powered by 1 or more cells which
20 convert chemical energy directly into electricity by combining
21 oxygen with hydrogen fuel that is stored on board the vehicle in
22 any form and that may require reformation prior to use.

23 (b) "Department" means the department of treasury.

24 (c) "Electric vehicle" means an all-electric vehicle or a
25 plug-in hybrid electric vehicle that has a manufacturer's suggested
26 retail price of \$80,000.00 or less and that is not subject to the
27 Federal Trade Commission's used motor vehicle trade regulation
28 rule, 16 CFR part 445. An electric vehicle does not include a
29 vehicle designed and built primarily for off-road use.

1 (d) "New electric vehicle" means an electric vehicle purchased
2 after October 1, 2022, and the purchaser is the first title holder
3 of that electric vehicle.

4 (e) "Plug-in hybrid electric vehicle" means a vehicle with
5 high-capacity batteries that can be charged by plugging them into
6 an electrical outlet or charging station and that is propelled by 1
7 or more electric motors and may also be propelled by a gasoline-
8 powered internal combustion engine, and may include a gasoline-
9 powered engine that is used only to generate power for the electric
10 motor.
