A bill to require certain institutions of higher education to make certain disclosures to students concerning their student loans; and to provide for the powers and duties of certain state and local governmental officers and entities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act may be cited as the "student loan disclosure
- 2 act".
- 3 Sec. 2. As used in this act, "institution of higher education"
- 4 means either of the following:

- 1 (a) A state institution of higher education described in

- 6 Sec. 3. (1) For the 2022-2023 academic year and each academic
- 7 year thereafter, an institution of higher education that receives
- 8 federal education loan information or other student loan
- 9 information regarding a student enrolled at the institution shall
- 10 provide the following to the student on an annual basis at a time
- 11 determined by the institution, but no later than July 1 of the
- 12 academic year:
- 13 (a) An estimate of the total amount of federal education loans
- 14 or other student loans that are disbursed by the institution taken
- 15 out by the student.
- 16 (b) Subject to section 4, an estimate of the total payoff
- 17 amount of the federal education loans or other student loans that
- 18 are disbursed by the institution incurred by the student enrolled
- 19 at the institution of higher education, if the loans were to go
- 20 into repayment as of the date of the annual notification under this

- (c) The number of years used in determining the potential

- 26 (2) An institution of higher education shall provide the

- 1 institution's protocol for communicating grades.
- 2 Sec. 4. The information provided to a student under section 3
- 3 may include a statement that any estimate or range provided is
- 4 general in nature and not intended to be a guarantee or promise of
- 5 an actual projected amount. The statement must include a disclaimer
- 6 that the information provided under section 3 pertains only to
- 7 federal loans disbursed at the institution of higher education that
- 8 is providing the information or any loans disbursed directly from
- 9 the institution.
- Sec. 5. (1) An institution of higher education shall not incur
- 11 liability for any representation made under this act.
- 12 (2) An institution of higher education may comply with section
- 13 3 by contracting with a student loan servicer to provide the
- 14 information required under section 3, if the student loan servicer
- 15 provides the information required under section 3(1) in the manner
- 16 required under section 3(2).
