November 09, 2022, Introduced by Rep. Steven Johnson and referred to the Committee on Regulatory Reform.

A bill to amend 1979 PA 152, entitled  
"State license fee act,"  
by amending section 17 (MCL 338.2217), as amended by 2019 PA 71.

## **THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**
