THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 105. (1) "Alcohol" means the product of distillation of
- 2 fermented liquid, whether or not rectified or diluted with water,
- 3 but does not mean ethyl or industrial alcohol, diluted or not, that
- 4 has been denatured or otherwise rendered unfit for beverage
- 5 purposes.
- 6 (2) "Alcohol vapor device" means any device that provides for
- 7 the use of air or oxygen bubbled through alcoholic liquor to
- 8 produce a vapor or mist that allows the user to inhale this
- 9 alcoholic vapor through the mouth or nose.

- 1 (3) "Alcoholic liquor" means any spirituous, vinous, malt, or
- 2 fermented liquor, powder, liquids, and compounds, whether or not
- 3 medicated, proprietary, patented, and by whatever name called,
- 4 containing 1/2 of 1% or more of alcohol by volume that are fit for
- 5 use for food purposes or beverage purposes as defined and
- 6 classified by the commission according to alcoholic content as
- 7 belonging to 1 of the varieties defined in this chapter.
- **8** (4) "Alternating proprietorship" means 1 of the following:
- 9 (a) An arrangement in which 2 or more wine makers or small
- 10 wine makers take turns using the same space and equipment to
- 11 manufacture wine pursuant to as defined in section 113(9)(a) or
- 12 113a(9)(a) under section 603(9)(a) and in accordance with 27 CFR
- **13** 24.136.
- 14 (b) An arrangement in which 2 or more brewers or micro brewers
- 15 take turns using the same space and equipment to manufacture beer
- 16 pursuant to section 603(9)(b) and in accordance with 27 CFR 25.52.
- 17 (5) "Approved tasting room" means a tasting room that is
- 18 approved by the commission.
- 19 (6) "Authorized distribution agent" means a person approved by
- 20 the commission to do 1 or more of the following:
- 21 (a) To store spirits owned by a supplier of spirits or the
- 22 commission.
- 23 (b) To deliver spirits sold by the commission to retail
- 24 licensees.
- 25 (c) To perform any function needed to store spirits owned by a
- 26 supplier of spirits or by the commission or to deliver spirits sold
- 27 by the commission to retail licensees.
- 28 (7) "Bar" means a barrier or counter at which alcoholic liquor
- 29 is sold to, served to, or consumed by customers.

(8) "Beer" means any a beverage obtained by alcoholic fermentation of an infusion or decoction of barley, malt, hops, sugar, or other cereal in potable water.

- (9) "Bottle" or "bottling" means a process, separate from manufacturing, using owned or leased equipment to fill and seal a container, including a keg, with alcoholic liquor for sale at wholesale or retail in accordance with this act. Bottle or bottling does not include filling a growler for sale at retail.
- (10) "Brand" means any word, name, group of letters, symbol, trademark, or combination thereof adopted and used by a supplier to identify a specific beer, malt beverage, wine, or mixed wine drink , or mixed spirit drink product and to distinguish that product from another beer, malt beverage, wine, or mixed wine drink 7 or mixed spirit drink product that is produced or marketed by that or another supplier. As used in this subsection, "supplier" means a brewer, micro brewer, an outstate seller of beer, a wine maker, a small wine maker, an outstate seller of wine, a manufacturer of mixed wine drink, or an outstate seller of a mixed wine drink. - a mixed spirit drink manufacturer, or an outstate seller of mixed spirit drink.
 - or a substantial part of the unique features of a preexisting brand of the same supplier. As used in this subsection, "supplier" means a brewer, micro brewer, an outstate seller of beer, a wine maker, a small wine maker, an outstate seller of wine, a manufacturer of mixed wine drink, or an outstate seller of a mixed wine drink. The mixed spirit drink manufacturer, or an outstate seller of mixed spirit drink.
- 29 (12) "Brandy" means an alcoholic liquor as defined in 27 CFR

- **1** 5.22(d).
- 2 (13) "Brandy manufacturer" means a wine maker or a small wine
- 3 maker licensed under this act to manufacture brandy. A wine maker
- 4 or small wine maker authorized to manufacture brandy shall not
- 5 manufacture any other spirits. The commission may approve a brandy
- 6 manufacturer to sell brandy that it manufactures at retail in
- 7 accordance with section 537.
- 8 (14) "Brewer" means a person located in this state that is
- 9 licensed to manufacture beer and sell at retail in accordance with
- 10 section 537 and to licensed wholesalers beer manufactured by it.the
- 11 person.
- 12 (15) "Brewpub" means a license issued in conjunction with a
- 13 class C, tavern, class A hotel, or class B hotel license that
- 14 authorizes the person licensed with the class C, tavern, class A
- 15 hotel, or class B hotel to manufacture and brew not more than
- 16 18,000 barrels of beer per calendar year in this state and sell at
- 17 its licensed premises the beer produced for consumption on or off
- 18 the licensed brewery premises in the manner provided for in
- 19 sections 405, 407, and 537.
- Sec. 107. (1) "Cash" means money in hand, bank notes, demand
- 21 deposits at a bank, or legal tender, which that a creditor must
- 22 accept according to law. Cash does not include call loans,
- 23 postdated checks, or promissory notes.
- 24 (2) "Class C license" means a place licensed to sell at retail
- 25 beer, wine, mixed spirit drink, and spirits for consumption on the
- 26 premises.
- 27 (3) "Class G-1 license" means a place licensed to sell at
- 28 retail beer, wine, mixed spirit drink, and spirits for consumption
- 29 on the premises at a golf course having at least 18 holes that

- 1 measure at least 5,000 yards and which license is issued only to a
- 2 facility that permits member access by means of payments that
- 3 include annual paid membership fees.
- 4 (4) "Class G-2 license" means a place licensed to sell at
- 5 retail beer and wine for consumption on the premises at a golf
- 6 course having at least 18 holes that measure at least 5,000 yards
- 7 and which license is issued only to a facility that permits member
- 8 access by means of payments that include annual paid membership
- 9 fees.
- 10 (5) "Club" means a nonprofit association, whether incorporated
- 11 or unincorporated, organized for the promotion of some common
- 12 purpose, the object of which is owning, hiring, or leasing a
- 13 building, or space in a building, of an extent and character as in
- 14 the judgment of the commission may be suitable and adequate for the
- 15 reasonable and comfortable use and accommodation of its members and
- 16 their guests, but does not include an association organized for a
- 17 commercial or business purpose.
- 18 (6) "Commission" means the liquor control commission created
- **19** in section 209.
- 20 (7) "Church" means an entire house or structure set apart
- 21 primarily for use for purposes of public worship, and that is tax
- 22 exempt under the laws of this state, and in which religious
- 23 services are held and with which a clergyman is associated, and the
- 24 entire structure of which is kept for that use and not put to any
- 25 other use inconsistent with that use.
- 26 (8) "Distiller" means a person licensed to manufacture and
- 27 sell spirits or alcohol, or both, of any kind.
- 28 (9) "Hotel" means a building or group of buildings located on
- 29 the same or adjoining pieces of real property, that provide lodging

- 1 to travelers and temporary residents and that may also provide food
- 2 service and other goods and services to registered guests and to
- 3 the public.
- 4 (10) "Class A hotel" means a hotel licensed by the commission
- 5 to sell beer and wine for consumption on the premises only, which
- 6 that provides for the rental of, and maintains the availability for
- 7 rental of, not less than 25 bedrooms if located in a local
- 8 governmental unit with a population of less than 175,000 or not
- 9 less than 50 bedrooms if located in a local governmental unit with
- 10 a population of 175,000 or more.
- 11 (11) "Class B hotel" means a hotel licensed by the commission
- 12 to sell beer, wine, mixed spirit drink, and spirits for consumption
- 13 on the premises only, that provides for the rental of, and
- 14 maintains the availability for rental of, not less than 25 bedrooms
- 15 if located in a local governmental unit with a population of less
- 16 than 175,000 or not less than 50 bedrooms if located in a local
- 17 governmental unit with a population of 175,000 or more.
- 18 (12) "Financial records" means any document or summary of
- 19 information contained in a document, including electronic
- 20 documents, that contains information about the financial activities
- 21 or position of a person including, but not limited to, information
- 22 about the assets, balance sheets, budgets, cash flow, earnings,
- 23 revenue, expenditures, income, investments, losses, liabilities,
- 24 payroll, profits, retained earnings, or taxes.
- 25 (13) "License" means a contract between the commission and the
- 26 licensee granting authority to that licensee to manufacture and
- 27 sell, or warehouse alcoholic liquor in the manner provided
- 28 by this act.
- Sec. 109. (1) "Manufacture" means to distill, rectify,

- 1 ferment, brew, make, produce, filter, mix, concoct, process, or
- 2 blend an alcoholic liquor or to complete a portion of 1 or more of
- 3 these activities. Manufacture does not include bottling or the
- 4 mixing or other preparation of drinks for serving by those persons
- 5 authorized under this act to serve alcoholic liquor for consumption
- 6 on the licensed premises. In addition, manufacture does not include
- 7 attaching a label to a shiner. All containers or packages of
- 8 alcoholic liquor must state clearly the name, city, and state of
- 9 the bottler.
- 10 (2) "Manufacturer" means, except as provided in section 603, a
- 11 person that manufactures alcoholic liquor, whether located in or
- 12 out of this state, including, but not limited to, a distiller, a
- 13 small distiller, a rectifier, a mixed spirit drink manufacturer, a
- 14 mixed wine drink manufacturer, a wine maker, a small wine maker, a
- 15 brewer, and a micro brewer.
- 16 (3) "Manufacturing premises" means the licensed premises of a
- 17 manufacturer where the manufacturer manufactures alcoholic liquor
- 18 or, for a small wine maker only, bottles wine.
- 19 (4) "Master distributor" means, except as provided in section
- 20 307, a wholesaler that acts in the same or similar capacity as a
- 21 brewer, wine maker, outstate seller of wine, or outstate seller of
- 22 beer for a brand or brands of beer or wine to other wholesalers on
- 23 a regular basis in the normal course of business.
- 24 (5) "Micro brewer" means a brewer that manufactures in total
- 25 less than 60,000 barrels of beer per year and that may sell the
- 26 beer manufactured to consumers at the licensed brewery premises for
- 27 consumption on or off the licensed brewery premises and to
- 28 retailers as provided in section 203a. In determining the 60,000-
- 29 barrel threshold, all brands and labels of a brewer, whether

manufactured in this state or outside this state, must be combined and all facilities for the manufacturing of beer that are owned or controlled by the same person must be treated as a single facility.

- (6) "Minor" means an individual less than 21 years of age.
- (7) "Mixed spirit drink" means a drink manufactured and packaged or sold by a mixed spirit drink manufacturer or sold by an outstate seller of mixed spirit drink to a wholesaler that contains 10% or less alcohol by volume consisting of spirits mixed with nonalcoholic beverages or flavoring or coloring materials and that may also contain 1 or more of the following:
- 11 (a) Water.

- 12 (b) Fruit juices.
- 13 (c) Fruit adjuncts.

- (8) "Mixed spirit drink manufacturer" means a person licensed
 under this act to manufacture mixed spirit drink in this state and
 to sell mixed spirit drink at retail in accordance with section 537
 or to a wholesaler. For purposes of rules promulgated by the
 commission, a mixed spirit drink manufacturer is treated as a wine
 manufacturer but is subject to the rules applicable to spirits for
 manufacturing and labeling.
 - (7) (9)—"Mixed wine drink" means a drink or similar product marketed as a wine cooler that contains less than 7% alcohol by volume, consists of wine and plain, sparkling, or carbonated water, and contains any 1 or more of the following:
- 28 (a) Nonalcoholic beverages.
- 29 (b) Flavoring.

- 1 (c) Coloring materials.
- 2 (d) Fruit juices.
- 3 (e) Fruit adjuncts.
- 4 (f) Sugar.

- 5 (g) Carbon dioxide.
- 6 (h) Preservatives.
- 7 (8) "Outstate self-distributor" means a person located in 8 another state that is the substantial equivalent of a micro brewer, 9 small distiller, or small wine maker licensed by the commission to 10 sell alcoholic liquor that the person manufactured outside this 11 state directly to a retailer under sections 203(20), 203a, and 203b 12 in accordance with rules promulgated by the commission. An applicant for an outstate self-distributor license must submit a 13 14 copy of its federal basic permit or brewer's notice and its 15 manufacturing license from the state of issuance.
 - (9) (10)—"Outstate seller of beer" means a person licensed by the commission to sell beer that has not been manufactured in this state, or beer that the person purchased from a limited production manufacturer, to a wholesaler in this state in accordance with rules promulgated by the commission. As used in this subsection, "limited production manufacturer" means a person licensed under section 504.
 - (11) "Outstate seller of mixed spirit drink" means a person licensed by the commission to sell mixed spirit drink that has not been manufactured in this state to a wholesaler in this state in accordance with rules promulgated by the commission. For purposes of rules promulgated by the commission, an outstate seller of mixed spirit drink is treated as an outstate seller of wine but is subject to the rules applicable to spirits for manufacturing and

- 1 labeling.
- 2 (10) (12) "Outstate seller of wine" means a person licensed by
- 3 the commission to sell wine that has not been manufactured in this
- 4 state to a wholesaler in this state in accordance with rules
- 5 promulgated by the commission and to sell sacramental wine as
- 6 provided in section 301. An outstate seller of wine is subject to
- 7 the administrative rules applicable to wine manufacturing and
- 8 labeling for wine as defined in section 113(9)(a) or 113a(9)(a). An
- 9 outstate seller of wine is subject to the administrative rules
- 10 applicable to spirits manufacturing and labeling for wine as
- 11 defined in section 113(9)(b) or 113a(9)(b). An outstate seller of
- 12 wine that sells only wine as defined in section 113(9)(b) or
- 13 113a(9)(b) is not subject to the administrative rules applicable to
- 14 wine manufacturing and labeling for wine as defined in section
- 15 113(9)(a) or 113a(9)(a). The commission shall reclassify an
- 16 outstate seller of mixed spirit drink license issued before May 1,
- 17 2021 to an outstate seller of wine license upon the licensee
- 18 demonstrating that it will comply with the administrative rules
- 19 applicable to spirits manufacturing and labeling for wine as
- 20 defined in section 113(9)(b) or 113a(9)(b).
- Sec. 111. (1) "Person" means an individual, firm, partnership,
- 22 limited partnership, association, limited liability company, or
- 23 corporation.
- 24 (2) "Primary source of supply" means, in the case of for
- 25 domestic spirits, the distiller, producer, owner of the commodity
- 26 at the time it becomes a marketable product, or bottler, or the
- 27 exclusive agent of the distiller, producer, owner of the commodity
- 28 at the time it becomes a marketable product, or bottler, and, for
- 29 spirits imported into the United States, either the foreign

- 1 distiller, producer, owner, or bottler, or the prime importer for,
- 2 or the exclusive agent in the United States of, the foreign
- 3 distiller, producer, owner, or bottler.
- 4 (3) "Professional account" means an account established for a
- 5 person by a class C licensee or tavern licensee whose major
- 6 business is the sale of food, by which the licensee extends credit
- 7 to the person for not more than 30 days.
- **8** (4) "Residence" means the premises in which a person resides
- 9 permanently.
- 10 (5) "Restaurant" means a food service establishment defined
- 11 and licensed under the food law, 2000 PA 92, MCL 289.1101 to
- 12 289.8111. A restaurant that does not hold a license issued by the
- 13 commission under this act shall not manufacture, market, deliver,
- 14 or sell alcoholic liquor in this state.
- 15 (6) "Retailer" means a person licensed by the commission that
- 16 sells to the consumer in accordance with rules promulgated by the
- 17 commission. Retailer includes a brewpub but does not include a
- 18 manufacturer or supplier, as defined in section 603, that is
- 19 allowed as a condition of its license to sell to consumers in this
- 20 state.
- 21 (7) "Sacramental wine" means wine containing not more than 24%
- 22 of alcohol by volume that is used for sacramental purposes.
- 23 (8) "Sale" includes the exchange, barter, traffic, furnishing,
- 24 delivery, or giving away of alcoholic liquor. For a sale in which a
- 25 shipment or delivery of alcoholic liquor is made by a common or
- 26 other carrier, the sale of the alcoholic liquor is considered to be
- 27 made in the county within which the delivery of the alcoholic
- 28 liquor is made by that carrier to the consignee or his or her agent
- 29 or employee, and venue for the prosecution for that sale may be in

- the county or city where the seller resides or from which theshipment is made or at the place of delivery.
- 3 (9) "School" includes buildings used for school purposes to4 provide instruction to children in grades kindergarten through 12,
- 5 if that instruction is provided by a public, private,
- 6 denominational, or parochial school, except those buildings used
- 7 primarily for adult education or college extension courses. School
- 8 does not include a proprietary trade or occupational school.
- 9 (10) "Shiner" means an unlabeled, sealed container of wine,
- 10 including a keg, that is sold by a wine maker, small wine maker, or
- 11 out-of-state entity that is the substantial equivalent of a wine
- 12 maker or small wine maker to another wine maker, small wine maker,
- 13 or out-of-state entity that is the substantial equivalent of a wine
- 14 maker or small wine maker. The purchasing wine maker or small wine
- 15 maker must attach a label to the container using equipment owned or
- 16 leased by the purchasing wine maker or small wine maker, register
- 17 the wine label with the commission, and sell it as provided for in
- 18 this act.
- 19 (11) "Small distiller" means a manufacturer of spirits
- annually manufacturing in this state not more than 60,000 gallons
- 21 of spirits, of all brands combined.
- 22 (12) "Small wine maker" means a wine maker manufacturing or
- 23 bottling not more than 50,000 gallons of wine in 1 calendar year. A
- 24 small wine maker is not required to bottle wine it manufactures. A
- 25 small wine maker that manufactures only wine as defined in section
- 26 113(9)(b) or 113a(9)(b) is not subject to the administrative rules
- 27 applicable to wine manufacturing and labeling for wine as defined
- 28 in section 113(9)(a) or 113a(9)(a). The commission shall reclassify
- 29 a manufacturer of mixed spirit drink license issued before May 1,

- 1 2021 to a small wine maker license upon the licensee demonstrating
- 2 that it will comply with the administrative rules applicable to
- 3 spirits manufacturing and labeling for wine as defined in section
- 4 113(9)(b) or 113a(9)(b).
- 5 (13) "Special license" means a contract between the commission
- 6 and the special licensee granting authority to that licensee to
- 7 sell beer, wine, mixed spirit drink, or spirits. The license must
- 8 be granted only to the persons and the organization and for the
- 9 period of time that the commission determines if the person or
- 10 organization is able to demonstrate an existence separate from an
- 11 affiliated umbrella organization. If such an existence is
- 12 demonstrated, the commission shall not deny a special license
- 13 solely by the applicant's affiliation with an organization that is
- 14 also eligible for a special license.
- 15 (14) "Specially designated distributor" means, subject to
- 16 section 534, a person engaged in an established business licensed
- 17 by the commission to distribute spirits and mixed spirit drink in
- 18 the original package for the commission for consumption off the
- 19 premises.
- 20 (15) "Specially designated merchant" means a person to whom
- 21 the commission grants a license to sell beer, or wine, or both, at
- 22 retail for consumption off the licensed premises.
- 23 (16) "Spirits" means a beverage that contains alcohol obtained
- 24 by distillation, mixed with potable water or other substances, or
- 25 both, in solution, and includes wine containing an alcoholic
- 26 content of more than 21% by volume, except sacramental wine and
- 27 mixed spirit drink.
- 28 (17) "State liquor store" means a store established by the
- 29 commission under this act for the sale of spirits in the original

- 1 package for consumption off the premises.
- 2 (18) "Successor to a supplier that continues in business"
- 3 means a supplier that acquires a brand or brands from another
- 4 supplier and remains in business after it acquires that brand or
- 5 brands. As used in this subsection, "supplier" means any of the
- 6 following:
- 7 (a) Brewer.
- 8 (b) Outstate seller of beer.
- **9** (c) Master distributor.
- 10 (d) Wine maker.
- 11 (e) Outstate seller of wine.
- 12 (19) "Supplier of spirits" means a vendor of spirits, a
- 13 manufacturer of spirits, or a primary source of supply.
- 14 Sec. 113. (1) "Tasting room" means any of the following
- 15 locations:
- 16 (a) A location on the manufacturing premises of a brewer or
- 17 micro brewer where the brewer or micro brewer may provide samples
- 18 of or sell at retail for consumption on or off the premises, or
- 19 both, beer it manufactures.
- 20 (b) A location on or off the manufacturing premises of a wine
- 21 maker or small wine maker where the wine maker or small wine maker
- 22 may provide samples of or sell at retail for consumption on or off
- 23 the premises, or both, shiners, wine it manufactured, or, for a
- 24 small wine maker only, wine it bottled.
- (c) A location on or off the manufacturing premises of a
- 26 distiller or small distiller where the distiller or small distiller
- 27 may provide samples of or sell at retail for consumption on or off
- 28 the premises, or both, spirits it manufactured.
- 29 (d) A location on the manufacturing premises of a mixed spirit

- 1 drink manufacturer where the mixed spirit drink manufacturer may
- 2 provide samples of or sell at retail for consumption on or off the
- 3 premises, or both, mixed spirit drinks it manufactured.
- 4 (d) (e)—A location on or off the manufacturing premises of a
- 5 brandy manufacturer where the brandy manufacturer may provide
- 6 samples of or sell at retail for consumption on or off the
- 7 premises, or both, brandy it manufactured.
- 8 (2) "Tavern" means any place licensed to sell at retail beer
- 9 and wine for consumption on the premises only.
- 10 (3) "Vehicle" means any means of transportation by land, by
- 11 water, or by air.
- 12 (4) "Vendor" means a person licensed by the commission to sell
- 13 alcoholic liquor.
- 14 (5) "Vendor of spirits" means a person selling spirits to the
- 15 commission.
- 16 (6) "Warehouse" means a premises or place primarily
- 17 constructed, used, or provided with facilities for the storage in

For a branch, chapter, lodge, 18 aerie, or other local unit of a national fraternal nonprofit 19 association that is exempt from federal income taxes under section 20 501(c)(8) or 501(c)(10) of the internal revenue code of 1986, 26 USC 501, a bona fide member includes a member of another branch, 21 22 chapter, lodge, aerie, or local unit who possesses an 23 identification card indicating current membership in the same 24 national fraternal nonprofit association. 25 (2) Except as otherwise provided in subsection (3), the
- 26 commission shall not issue a license to a club unless the club has 27 been in existence for a period of not less than 2 or more years 28 before the application for the license.
- 29 (3) A club shall give public notice of the intent of the
