A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 802 (MCL 257.802), as amended by 2019 PA 88.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 802. (1) For a special registration issued under section
- 2 226(8), the registrant shall pay 1/2 the tax imposed under section
- **3** 801 and a service fee of \$10.00.
- 4 (2) For all commercial vehicles registered after August 31 for
- 5 the period expiring the last day of February, the secretary of

- 1 state shall collect a tax of 1/2 the rate otherwise imposed under
- 2 this act. This subsection does not apply to vehicles registered by
- 3 manufacturers or dealers under sections 244 to 247.
- 4 (3) For each special registration under section 226(9), the
- 5 secretary of state shall collect a service fee of \$10.00.
- **6** (4) For temporary registration plates or markers under section
- 7 226a(1), the secretary of state shall collect a service fee in an
- 8 amount determined by the secretary of state to reflect the actual
- 9 cost of administering the temporary registration plates and markers
- 10 program, or in the amount of \$4.00 per plate or marker, whichever
- 11 is less.
- 12 (5) For a temporary registration under section 226b, the fee

- 14 (a) For a 30-day temporary registration, 1/10 of the tax

- 17 (b) For a 60-day temporary registration, 1/5 of the tax

- 20 (6) For registration plates as provided for in section
- 21 226a(5), (6), and (7), the secretary of state shall collect a
- 22 service fee of \$40.00 for 2 registration plates and \$20.00 for each
- 23 additional registration plate.
- 24 (7) For special registrations issued for special mobile
- 25 equipment as provided in section 216(d), the secretary of state
- 26 shall collect a service fee of \$15.00 each for the first 3 special
- 27 registrations, and \$5.00 for each special registration issued in

- 29 (8) The secretary of state, upon request, may issue a

- 1 registration valid for 3 months for use on a vehicle with an
- 2 elected gross weight of 24,000 pounds or greater on the payment of
- 3 1/4 the tax provided in section 801(1)(k) and a service fee of
- **4** \$10.00.
- 5 (9) Upon application to the secretary of state, an owner of a
- 6 truck, truck tractor, or road tractor that is used exclusively for
- 7 the purpose of gratuitously transporting farm crops or livestock
- 8 bedding between the field where produced and the place of storage,
- 9 feed from on-farm storage to an on-farm feeding site, or
- 10 fertilizer, seed, or spray material from the farm location to the
- 11 field may obtain a special registration. The service fee for each
- 12 special registration issued under this subsection is \$20.00. The
- 13 special registration is valid for a period of up to 12 months and
- 14 expires on December 31. As used in this subsection:
- 15 (a) "Feed" means hay or silage.
- (b) "Livestock bedding" means straw, sawdust, or sand.
- 17 (10) Beginning on January 1, 2022, the secretary of state
- 18 shall provide a system for applicants under subsection (9) to renew
- 19 their special registration online or by first-class mail at no
- 20 additional charge.
- 21 (11) (10)—The secretary of state, upon request, may issue a
- 22 special registration valid for 3 or more months for a road tractor,
- 23 truck, or truck tractor owned by a farmer, if the motor vehicle is
- 24 used exclusively in connection with the farmer's farming operations
- 25 or for the transportation of the farmer and the farmer's family and
- 26 not used for hire. The fee for the registration is 1/10 of the tax
- 27 provided in section 801(1)(c) times the number of months for which
- 28 the special registration is requested and, in addition, a service
- 29 fee of \$10.00. The secretary of state shall not issue a special

- registration for a motor vehicle for which the tax under section 801(1)(c) would be less than \$50.00.
- 3 (12) (11) The secretary of state, upon request, may issue a
 4 registration valid for 3 months or more for use on a vehicle with
- 5 an elected gross weight of 24,000 pounds or greater. The fee for
- 6 the registration shall be 1/12 of the tax provided in section
- 7 801(1)(k), times the number of months for which the special
- 8 registration is requested and, in addition, a service fee of
- **9** \$10.00.
- 10 (13) (12) The secretary of state shall deposit the service
- 11 fees collected under subsections (1), (3), (4), (5), (6), (7), (8),
- 12 (9), $\frac{(10)}{(11)}$, and $\frac{(11)}{(12)}$ in the transportation administration
- 13 collection fund created in section 810b through October 1, 2023.
