- 20 (i) 1 to 20 locations, \$500.00.
- 21 (ii) 21 to 50 locations, \$750.00.
- 22 (iii) 51 to 75 locations, \$2,000.00.
- (iv) More than 75 locations, \$3,000.00.
- 24 If a person operates more than 1 vending company base location
- 25 in this state, all vending machine locations served by those

- 1 (j) Food service establishment: the amounts described in 2 subsection (2).
- 3 (2) If a local health department no longer conducts a food4 service program, the department, in consultation with the
- 5 commission of agriculture and rural development, shall set the food

- 6 sanitation fees to be imposed for the conduct of the food service
- 7 program by the department. The fees imposed must equal, as nearly
- 8 as possible, 1/2 of the department's cost of providing the service.
- 9 The department may impose the service fees for up to 12 months
- 10 after the date of cessation by the local health department. After
- 11 the 12-month period, the department shall collect the fees only as

- 13 (3) Any license fee paid on an initial application is 14 nonrefundable.
- 15 (4) The department may charge a convenience fee and collect
 16 from the applicant any additional costs associated with the method
 17 of fee payment for the license or permit fees described in this
 18 chapter, not to exceed the costs to the department.
 - (5) The department shall not charge a license fee described under subsection (1) or a late fee described under section 4113 for an initial license or renewal license application submitted at any time during the licensing year that begins May 1, 2021 and ends at midnight on April 30, 2022.
