A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 2253 and 2453 (MCL 333.2253 and 333.2453), section 2253 as amended by 2006 PA 157.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2253. (1) If Except as otherwise provided in subsection
- 2 (4), if the director determines that control of an epidemic is

- 8 (e) "School" means a public school or nonpublic school as
 9 those terms are defined in section 5 of the revised school code,

- 11 Sec. 2453. (1) If Except as otherwise provided in subsection
- 12 (3), if a local health officer determines that control of an
- 13 epidemic is necessary to protect the public health, the local
- 14 health officer may issue an emergency order to prohibit the
- 15 gathering of people for any purpose and may establish procedures to
- 16 be followed by persons, including a local governmental entity,
- 17 during the epidemic to insure ensure continuation of essential
- 18 public health services and enforcement of health laws. Emergency
- 19 procedures shall are not be limited to this code.
- 20 (2) A local health department or the department may provide
- 21 for the involuntary detention and treatment of individuals with
- 22 hazardous communicable disease in the manner prescribed in sections
- 23 5201 to 5238.5210.
- 24 (3) A local health officer shall not issue an emergency order 25 under this section that does any of the following:
- 26 (a) Prohibits 1 or more family members from observing another 27 family member participate in a qualified sporting event.
- 28 (b) Prohibits in-person dining at the same table by 1 or more 29 family members at a food service establishment.

- 1 (c) Restricts individuals from more than 1 household from 2 gathering inside or outside of a private residence.
- 3 (4) As used in this section, "family member", "food service
- 4 establishment", "household", "qualified sporting event", and
- 5 "school" mean those terms as defined in section 2253.
