## **SENATE BILL NO. 680**

October 06, 2021, Introduced by Senators OUTMAN, BARRETT, RUNESTAD, SANTANA, IRWIN and SCHMIDT and referred to the Committee on Health Policy and Human Services.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 7303, 17201, 17210, 17211a, and 17212 (MCL 333.7303, 333.17201, 333.17210, 333.17211a, and 333.17212), section 7303 as amended by 2013 PA 268, sections 17201 and 17212 as amended and section 17211a as added by 2016 PA 499, and section 17210 as amended by 2021 PA 53, and by adding section 17210a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 7303. (1) A-Subject to subsection (9), a person who

- 1 manufactures, distributes, prescribes, or dispenses a controlled
- 2 substance in this state or who proposes to engage in the
- 3 manufacture, distribution, prescribing, or dispensing of a
- 4 controlled substance in this state shall obtain a license issued by
- 5 the administrator in accordance with the rules. A person who has
- 6 been issued a controlled substances license by the administrator
- 7 under this article and a license under article 15 shall renew the
- 8 controlled substances license concurrently with the renewal of the
- 9 license issued under article 15, and for an equal number of years.
- 10 (2) A person licensed by the administrator under this article
- 11 to manufacture, distribute, prescribe, dispense, or conduct
- 12 research with controlled substances may possess, manufacture,
- 13 distribute, prescribe, dispense, or conduct research with those
- 14 substances to the extent authorized by its license and in
- 15 conformity with the other provisions of this article.
- 16 (3) A license issued under this article to manufacture,
- 17 distribute, prescribe, or dispense pharmaceutical-grade cannabis
- 18 and the conduct of the licensee is subject to the additional
- 19 requirements of article 8.
- 20 (4) The following persons need not be licensed and may
- 21 lawfully possess controlled substances or prescription forms under
- 22 this article:
- (a) An agent or employee of a licensed manufacturer,
- 24 distributor, prescriber, or dispenser of a controlled substance if
- 25 acting in the usual course of the agent's or employee's business or
- 26 employment.
- 27 (b) A common or contract carrier or warehouseman, or an
- 28 employee thereof, whose possession of a controlled substance or
- 29 prescription form is in the usual course of business or employment.

(c) An ultimate user or agent in possession of a controlled substance or prescription form pursuant to a lawful order of a practitioner or in lawful possession of a schedule 5 substance.

- 4 (5) The administrator may waive or include by rule the
  5 requirement for licensure of certain manufacturers, distributors,
  6 prescribers, or dispensers, if it finds the waiver or inclusion is
  7 consistent with the public health and safety.
  - (6) A separate license is required at each principal place of business or professional practice where the applicant manufactures, distributes, prescribes, or dispenses controlled substances.
  - (7) As a requisite for licensure, the administrator may inspect the establishment of a licensee or applicant for licensure in accordance with the administrator's rule.
- 14 (8) A person licensed under this article to distribute 15 controlled substances shall report to the administrator on a quarterly basis all schedule 2 controlled substances and those 16 17 controlled substances designated by the administrator pursuant to 18 this subsection that are sold to licensed practitioners and retail 19 pharmacies. The report shall must be in writing and shall must 20 include the name of each licensed practitioner and retail pharmacy to whom the controlled substance was distributed. A report under 21 22 this subsection may be transmitted electronically, if the 23 transmission is ultimately reduced to writing. The administrator 24 shall designate by rule the controlled substances in schedules 3 to 25 5 to be reported under this subsection.
  - (9) The administrator may issue a controlled substances license to an individual licensed as a registered professional nurse under part 172 if the individual has been granted a specialty certification as a nurse practitioner by the Michigan board of

- 2 Sec. 17201. (1) As used in this part:
- 3 (a) "Advanced practice registered nurse" or "a.p.r.n." means a
- 4 registered professional nurse who has been granted a specialty
- 5 certification under section 17210 in 1 of the following health
- 6 profession specialty fields:
- 7 (i) Nurse midwifery.
- 8 (ii) Nurse practitioner.
- 9 (iii) Clinical nurse specialist.
- 10 (b) "Physician" means a physician who is licensed under part
- **11** 170 or part 175.

- 12 (c) "Practice Subject to sections 17210 and 17210a, "practice
- 13 of nursing" means the systematic application of substantial
- 14 specialized knowledge and skill, derived from the biological,
- 15 physical, and behavioral sciences, to the care, treatment, counsel,
- 16 and health teaching of individuals who are experiencing changes in

- 24 professional nurse, physician, or dentist.
- 25 (e) "Registered professional nurse" or "r.n." means an
- 26 individual who is licensed under this part to engage in the
- 27 practice of nursing which scope of practice includes the teaching,
- 28 direction, and supervision of less skilled personnel in the
- 29 performance of delegated nursing activities.

- (2) In addition to the definitions in this part, article 1
   contains general definitions and principles of construction
   applicable to all articles in the code and part 161 contains
   definitions applicable to this part.
- Sec. 17210. (1) The Michigan Subject to this section and
  section 17210a, the board of nursing may grant a specialty
  certification to a registered professional nurse who has advanced
  training beyond that required for initial licensure, who has
  demonstrated competency through examination or other evaluative
  processes, and who practices in 1 of the following health
  profession specialty fields:
- 12 (a) Nurse midwifery.

- 13 (b) Nurse anesthetist.
- 14 (c) Nurse practitioner.
- 15 (d) Subject to subsection (2), clinical Clinical nurse
  16 specialist.
- 17 (2) The Michigan board of nursing shall promulgate rules
  18 establishing the qualifications for the training and competency of
  19 the health profession specialty field of clinical nurse specialist.
  20 The Michigan board of nursing shall not grant a specialty
  21 certification as a clinical nurse specialist under subsection (1)
  22 until after the effective date of the rules promulgated under this subsection.
  - (3) All of the following apply to a registered professional nurse who holds a specialty certification as a nurse anesthetist:
  - (a) In addition to performing duties within the scope of the practice of nursing, his or her scope of practice includes any of the following anesthesia and analgesia services if the services are performed in accordance with the American Association of Nurse

- (i) Development of a plan of care.

- 3 (ii) Performance of all patient assessments, procedures, and
  4 monitoring to implement the plan of care or to address patient
  5 emergencies that arise during implementation of the plan of care.
  - (iii) Selection, ordering, or prescribing and the administration of anesthesia and analgesic agents, including pharmacological agents that are prescription drugs as defined in section 17708 or controlled substances. For purposes of this subparagraph, the authority of a registered professional nurse who holds a specialty certification as a nurse anesthetist to prescribe pharmacological agents is limited to pharmacological agents for administration to patients as described in subdivision (b), (c), or (d), and his or her authority does not include any activity that would permit a patient to self-administer, obtain, or receive pharmacological agents, including prescription drugs or controlled substances, outside of the facility in which the anesthetic or analgesic service is performed or beyond the perioperative, periobstetrical, or periprocedural period.
- 20 (b) If he or she meets both of the following requirements, he 21 or she may provide the anesthesia and analgesia services described 22 in subdivision (a) without supervision:
  - (i) He or she meets either of the following:
- (A) He or she has practiced in the health profession specialty field of nurse anesthetist for 3 years or more and has practiced in that health profession specialty field in a health care facility for a minimum of 4,000 hours.
- (B) He or she has a doctor of nurse anesthesia practice degreeor doctor of nursing practice degree.

- ${f 1}$  (ii) He or she is collaboratively participating in a patient- centered care team.
- 3 (c) He or she may provide the anesthesia and analgesia
  4 services described in subdivision (a) in a health care facility if
  5 the health care facility has a policy in place under subsection (4)
  6 allowing for the provision of the anesthesia and analgesia services
  7 and ensuring that a qualified health care professional is
  8 immediately available in person or through telemedicine to address
  9 any urgent or emergent clinical concerns.
- (d) The anesthesia and analgesia services described in
  subdivision (a) may be performed for and during the perioperative,
  periobstetrical, or periprocedural period.
  - (e) If he or she is practicing pain management in a freestanding pain clinic, he or she must be under the supervision of a physician.
  - (4) A health care facility may adopt policies relating to the provision of anesthesia and analgesia services. If a health care facility uses a registered professional nurse who holds a specialty certification as a nurse anesthetist to perform the anesthesia and analgesia services described in subsection (3) who is not employed by the health care facility, the health care facility shall ensure that the registered professional nurse or the person employing the registered professional nurse maintains malpractice insurance.
  - (5) Subsection (3) does not require new or additional third party reimbursement or mandated worker's compensation benefits for anesthesia and analgesia services provided under that subsection by a registered professional nurse who holds a specialty certification as a nurse anesthetist under this part.
    - (6) As used in this section:

- (a) "Collaboratively participating" means practicing and
   communicating with health care professionals involved in the
   patient-centered care team to optimize the overall care delivered
   to the patient.
- 5 (b) "Health care facility" means any of the following:
- 6 (i) A hospital inpatient or outpatient facility.
- 7 (ii) A freestanding surgical outpatient facility.
- 8 (iii) An office of a physician, podiatrist, or dentist.
- 9 (iv) Any other office or facility in which diagnostic or10 therapeutic procedures are provided to a patient, including, but
- 11 not limited to, imaging, endoscopy, or cystoscopy services.
- (c) "Health care professional" means an individual who is
  licensed or registered to perform a health profession under this
  article.
- (d) "Patient-centered care team" means a group of health care professionals, which must include, but is not limited to, a qualified health care professional, who directly or indirectly care for a patient by each contributing his or her specialized

knowledge, skill, and experience to the care of the patient.

- (e) "Qualified health care professional" means any of the following health care professionals who has completed the necessary education, training, and experience in anesthesia care or pharmacology, or has experience with procedures requiring
- 24 anesthesia:

- 25 (i) A physician.
- 26 (ii) A dentist licensed under part 166.
- 27 (iii) A podiatric physician licensed under part 180.
- Sec. 17210a. (1) The board may grant a specialty certification as a nurse practitioner under section 17210 to a registered

- 1 professional nurse who meets all of the following requirements:
- 2 (a) Has completed a graduate, postgraduate, or doctoral level
- 3 nursing education program that the board determines prepares the
- 4 registered professional nurse for the health profession specialty
- 5 field of nurse practitioner.
- 6 (b) Has completed a graduate level course in pharmacology,
- 7 pathophysiology, and physical assessment, or their equivalent as
- 8 determined by the board, and has completed a clinical practicum
- 9 applicable to the health profession specialty field of nurse
- 10 practitioner.
- 11 (c) Holds a certification from a nationally accredited
- 12 certification body approved by the board.
- 13 (d) Meets any other requirement established by the board by
- 14 rule.
- 15 (2) All of the following apply to a registered professional
- 16 nurse who holds a specialty certification as a nurse practitioner:
- 17 (a) In addition to performing duties within the practice of

- 20 (i) Performing comprehensive assessments, providing physical
- 21 examinations and other health assessments, and providing screening
- 22 activities.
- (ii) Diagnosing, treating, and managing patients with acute and

- 25 (iii) Ordering, performing, supervising, and interpreting
- 26 laboratory and imaging studies.
- 27 (iv) Prescribing pharmacological and nonpharmacological
- 28 interventions and treatments that are within the registered
- 29 professional nurse's specialty role.

- 1 (v) Engaging in health promotion and disease prevention.
- 2 (vi) Providing health education.
- 3 (vii) Counseling patients and families with potential, acute, 4 and chronic health disorders.
- 5 (b) He or she shall do all of the following:
- 6 (i) Provide only the functions common to the population for
  7 which a registered professional nurse who holds a specialty
  8 certification as a nurse practitioner is educationally and
  9 experientially prepared.
- 10 (ii) Comply with the standards established by the board and
  11 with the national accreditation standards of the national
  12 professional nursing associations applicable to his or her
  13 specialty certification.
- 14 (iii) Consult with other health professionals and refer a 15 patient to other health professionals, as appropriate.
- 16 (c) He or she may supervise registered professional nurses, 17 licensed practical nurses, and other health professionals, as 18 appropriate.
- 19 Sec. 17211a. (1) An advanced practice registered nurse may 20 prescribe any of the following:
- 21 (a) A nonscheduled prescription drug.
- 22 (b) Subject to subsection (2), Except as otherwise provided in 23 subsection (2), a controlled substance included in schedules 2 to 5 24 of part 72, as a delegated act of a physician.
- 25 (2)—If an advanced practice registered nurse prescribes a
  26 controlled substance under subsection (1)(b), this subdivision,
  27 both the advanced practice registered nurse's name and the
  28 physician's name shall must be used, recorded, or otherwise
  29 indicated in connection with that prescription, . If an advanced
