- 1 A resolution to declare June 2021 as Elder Abuse Awareness
- 2 Month in the state of Michigan.
- 3 Whereas, On June 15, 2006, World Elder Abuse Awareness Day was
- 4 launched by the International Network for the Prevention of Elder
- 5 Abuse and the World Health Organization at the United Nations,
- 6 among other international organizations; and

- 1 Whereas, Estimates show that more than 1 in 10 persons over
- 2 the age of 60 are victims of elder abuse each year; and
- 3 Whereas, The vast majority of the abuse, neglect, and
- 4 exploitation of older adults in the United States goes
- 5 unidentified, as only 1 in 24 cases of abuse of older adults is
- 6 reported; and
- 7 Whereas, Elder abuse, neglect, and exploitation have no
- 8 boundaries and cross all racial, social, class, gender, and
- 9 geographic lines; and
- 10 Whereas, Older adults who are abused are at a higher risk to
- 11 die earlier than older adults of the same age who are not abused;

- 13 Whereas, Public awareness has the potential to increase the
- 14 identification and reporting of elder abuse by the public,
- 15 professionals, and victims, and can act as a catalyst to promote
- 16 issue-based education and long-term prevention; and
- 17 Whereas, Private individuals and public agencies must work
- 18 together on the federal, state, and local levels to combat
- 19 increasing occurrences of abuse, neglect, and exploitation crime
- 20 and violence against vulnerable older adults and vulnerable adults,
- 21 particularly in light of limited resources for vital protective
- 22 services; and
- 23 Whereas, 2021 is the 16th celebration of World Elder Abuse
- 24 Awareness Day; now, therefore, be it
- 25 Resolved by the House of Representatives, That the members of
- 26 this legislative body declare June 2021, as Elder Abuse Awareness
- 27 Month in the state of Michigan; and be it further
- 28 Resolved, That we recognize judges, lawyers, adult protective
- 29 services professionals, law enforcement officers, long-term care

- 1 ombudsmen, social workers, health care providers, professional
- 2 guardians, advocates for victims, and other professionals and
- 3 agencies for their efforts to advance awareness of elder abuse. We
- 4 encourage members of the public and professionals who work with
- 5 older adults to act as catalysts to promote awareness and long-term
- 6 prevention of elder abuse by reaching out to local adult protective
- 7 services agencies, long-term care ombudsman programs, and the
- 8 National Center on Elder Abuse, and by learning to recognize,
- 9 detect, report, and respond to elder abuse.
