HOUSE RESOLUTION NO.252

Rep. Tate offered the following resolution:

- 1 A resolution to condemn the actions of illegitimate
- 2 presidential electors and to encourage the attorneys general of
- 3 Michigan, Arizona, Georgia, Pennsylvania, Nevada, New Mexico, and
- 4 Wisconsin, along with the federal Department of Justice, to
- 5 prosecute these fake electors for their misdeeds to the fullest
- 6 extent of the law.
- 7 Whereas, Our country's system of elections is sacred and must
- 8 be adhered to by all parties, especially those in power, in the
- 9 name of democracy and justice. Political campaigns and actors that
- 10 seek to undermine unequivocal election results tear at the fabric
- 11 of the founding principles of our nation; and
- 12 Whereas, Presidential electors for each state are determined
- 13 when voters cast their ballot for President and Vice President. The

slate of electors for the winning candidates of a state are 1 appointed as that state's electors under federal and state laws. 2 These presidential electors then duly assemble in their respective 3 state capitals to certify the winning candidates and send the 4 5 certificates to Congress to count and declare the winners; and 6 Whereas, In a subversion of our laws and democratic process 7 following the 2020 election, groups in Michigan, Arizona, Georgia, 8 Pennsylvania, Nevada, New Mexico, and Wisconsin tied to the losing 9 candidate, Donald Trump, purported to be presidential electors and 10 submitted false certificates. This scheme is reported to be a 11 concerted effort stemming from the Trump Campaign. Co-chair of the Michigan Republican Party, Meshawn Maddock, was quoted at an event 12 13 saying, "We fought to seat the electors...the Trump campaign asked 14 us to do that..."; and 15 Whereas, The plot to arrange for fake presidential electors is 16 a perversion of our government and values that is part and parcel of the continued falsehoods over the safe, secure, and legitimate 17 2020 election. The lies and disinformation that have served to 18 19 foment violence and damage our democracy must stop and the 20 perpetrators be brought to justice; now, therefore, be it 21 Resolved by the House of Representatives, That we condemn the 22 actions of illegitimate presidential electors and encourage the 23 attorneys general of Michigan, Arizona, Georgia, Pennsylvania, 24 Nevada, New Mexico, and Wisconsin, along with the federal 25 Department of Justice, to prosecute these fake electors for their misdeeds to the fullest extent of the law; and be it further 26 27 Resolved, That copies of this resolution be transmitted to the 28 Michigan Attorney General, the Arizona Attorney General, the

Georgia Attorney General, the Pennsylvania Attorney General, the
