HOUSE RESOLUTION NO.262

Reps. Brenda Carter, Whiteford, Green, Wakeman, Brann, Kahle, Young, Pohutsky, Tyrone Carter and O'Malley offered the following resolution:

- 1 A resolution to urge the United States Congress to expand the
- 2 federal Family First Prevention Services Act by allowing
- 3 flexibility in the use of Title IV-E funds to help children remain
- 4 safely in their homes.
- 5 Whereas, In the United States, nearly half a million children
- 6 are in foster care. Michigan ranks 18th in the country for the
- 7 number of children, per capita, placed in out-of-home care, with
- 8 approximately 13,000 children in foster care or a residential
- 9 placement on any given day; and
- 10 Whereas, Research shows that children in the foster system
- 11 have the best outcomes when they are placed in a safe and stable

- 1 environment that supports their long-term well-being. Instead of
- 2 subjecting children to the trauma of being separated from their
- 3 family and placed out of their home, more efforts are being made to
- 4 provide struggling and overburdened families with the resources
- 5 they need to create a stable and loving environment; and
- 6 Whereas, The Family First Prevention Services Act, signed into
- 7 law in 2018, was enacted to help increase the number of children
- 8 who can remain safely at home with their families. The law allows
- 9 states to use federal funding available under Title IV-E of the
- 10 Social Security Act to address some of the issues that contribute
- 11 to family separation. Currently, the Family First Prevention
- 12 Services Act allows funding for a narrow range of services,
- 13 including substance use prevention and treatment, in-home parenting
- 14 skills classes, and kinship navigator services. While these
- 15 services are essential, there are many other areas in which
- 16 families require assistance; and
- 17 Whereas, Poverty and homelessness, for example, have been
- 18 shown to be associated with the separation of families, and many
- 19 studies have documented that children in families who experience
- 20 homelessness frequently become separated from their parents.
- 21 Poverty leads to housing instability and parents often struggle to
- 22 provide for their children's basic needs. Helping parents out of
- 23 poverty and providing stable environments for children would allow
- 24 more families to stay together, which would reduce the number of
- 25 children that have to endure the foster care system; now,
- 26 therefore, be it
- 27 Resolved by the House of Representatives, That we urge the
- 28 United States Congress to expand the federal Family First
- 29 Prevention Services Act by allowing flexibility in the use of Title

- 1 IV-E funds to help children remain safely in their homes; and be it
- 2 further
- 3 Resolved, That copies of this resolution be transmitted to the
- 4 Speaker of the United States House of Representatives, the
- 5 President of the United States Senate, and the members of the
- 6 Michigan congressional delegation.
