A bill to amend 1990 PA 187, entitled "The pupil transportation act,"

by amending sections 5 and 20 (MCL 257.1805 and 257.1820), section 5 as amended by 2006 PA 107 and section 20 as added by 2021 PA 52.

- 22 (c) Records the date, time, and location on a video recorded 23 or photograph captured by the system.
- Sec. 20. (1) A school bus may be equipped with a stop-arm camera system in accordance with this section.
 - (2) A school **district** may do either any of the following:
- (a) Install and operate a stop-arm camera system on a schoolbus.
