A bill to create the office of the tribal legislative liaison; and to prescribe the powers and duties of the office, the liaison, and the legislative council.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- (a) "Council" means the legislative council established undersection 15 of article IV of the state constitution of 1963.
- 4 (b) "Liaison" means the tribal legislative liaison.
- 5 (c) "Office" means the office of tribal legislative liaison6 created under this act.

- 1 Sec. 2. (1) The office of the tribal legislative liaison is
- 2 created within the legislative council to help establish and
- 3 maintain a government-to-government relationship between the
- 4 federally recognized tribes in this state and the legislature, and
- 5 to consult with the legislature during the development of
- 6 legislation that affects the federally recognized tribes in this
- 7 state.
- 8 (2) The principal executive officer of the office is the
- 9 tribal legislative liaison who shall be appointed by and serve at
- 10 the pleasure of the council.
- 11 (3) The council shall appoint the liaison from a list of not
- 12 fewer than 3 names provided by the elected council of sovereign
- 13 tribal leaders assembled as the United Tribes of Michigan, or a
- 14 successor organization.
- 15 Sec. 3. (1) The council shall establish procedures for
- 16 approving the budget of the office, for expending money in the
- 17 budget, and for the employment of personnel for the office.
- 18 (2) The personnel for the office must consist of not fewer
- 19 than all of the following individuals:
- 20 (a) The liaison.
- 21 (b) Two tribal legislative policy advisors, who are
- 22 responsible for legislative and policy work on behalf of the
- 23 liaison.
- 24 Sec 4. (1) The liaison shall do all of the following:
- 25 (a) Maintain a relationship with each federally recognized
- 26 tribe in this state and visit each tribe not less than once per
- **27** year.
- 28 (b) Provide guidance for members of the legislature and the
- 29 member's staff during the development of legislation based on how

- 1 proposed legislation may impact tribes and tribal members.
- 2 (c) Inform the legislature of the impact that specific
- 3 legislation will have on the tribes of this state.
- 4 (d) Provide an annual not less than hour-long training to
- 5 members of the legislature and the member's staff on each of the
- 6 following topics:
- 7 (i) How to consult and coordinate with the liaison.
- 8 (ii) The history and current state of the federally recognized
- 9 tribes in this state.
- 10 (2) The liaison may communicate with any tribal liaison in the
- 11 executive branch.
- 12 (3) By not later than December 31 of each year, the office
- 13 shall submit a written report to the governor, the senate majority
- 14 leader, the speaker of the house of representatives, and the
- 15 chairperson of each committee in the legislature that must include,
- 16 but is not limited to, a summary of concerns that were presented by
- 17 elected tribal leaders during the development of legislation in the
- 18 previous year. The office shall also post the written report
- 19 described in this subsection on a website that is accessible to the
- 20 public.
