## SUBSTITUTE FOR HOUSE BILL NO. 4063

A bill to amend 1976 PA 453, entitled "Elliott-Larsen civil rights act,"

by amending the title and section 501 (MCL 37.2501), as amended by 2023 PA 6.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE 1 2 An act to define civil rights; to prohibit discriminatory practices, policies, and customs in the exercise of those rights 3 based upon religion, race, color, national origin, age, sex, sexual 4 orientation, gender identity or expression, height, weight, 5 6 familial status, or marital status, or source of income; to preserve the confidentiality of records regarding arrest, 7 detention, or other disposition in which a conviction does not 8

- 1 result; to prescribe the powers and duties of the civil rights
- 2 commission and the department of civil rights; to provide remedies
- 3 and penalties; to provide for fees; and to repeal certain acts and
- 4 parts of acts.
- 5 Sec. 501. As used in this article:
- 6 (a) "Real property" includes a building, structure, mobile
- 7 home, real estate, land, mobile home park, trailer park, tenement,
- 8 leasehold, or an interest in a real estate cooperative or
- 9 condominium.
- 10 (b) "Real estate transaction" means the sale, exchange,
- 11 rental, or lease of real property, or an interest in real property.
- 12 (c) "Housing accommodation" includes improved or unimproved
- 13 real property, or a part of improved or unimproved real property,
- 14 that is used or occupied, or is intended, arranged, or designed to
- 15 be used or occupied, as the home or residence of 1 or more
- 16 individuals.
- 17 (d) "Real estate broker or salesperson" means a person,
- 18 whether licensed or not, who, for or with the expectation of
- 19 receiving a consideration, lists, sells, purchases, exchanges,
- 20 rents, or leases real property; who negotiates or attempts to
- 21 negotiate any of those activities; who holds oneself out as engaged
- 22 in those activities; who negotiates or attempts to negotiate a loan
- 23 secured or to be secured by a mortgage or other encumbrance upon
- 24 real property; who is engaged in the business of listing real
- 25 property in a publication; or a person employed by or acting on
- 26 behalf of a real estate broker or salesperson.
- 27 (e) "Source of income" means that term as defined in section 1
- 28 of 1972 PA 348, MCL 554.601.
