SUBSTITUTE FOR HOUSE BILL NO. 4129

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 931b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 931b. (1) An individual who intimidates an election
- 2 official because of the election official's status as an election
- 3 official, with the specific intent of interfering with the
- 4 performance of that election official's election-related duties, is
- 5 quilty of a crime as provided under subsection (3).
- 6 (2) An individual who prevents an election official from
- 7 performing the election official's duties in conducting an election
- 8 is guilty of a crime as provided under subsection (3).
- 9 (3) An individual who violates subsection (1) or (2) is guilty

- 1 of a crime as follows:
- 2 (a) For a first offense, the individual is quilty of a
- 3 misdemeanor punishable by imprisonment for not more than 93 days or
- 4 a fine of not more than \$500.00, or both.
- 5 (b) For a second offense, the individual is quilty of a
- 6 misdemeanor punishable by imprisonment for not more than 1 year or
- 7 a fine of not more than \$1,000.00, or both.
- 8 (c) For a third or subsequent offense, the individual is
- 9 quilty of a felony.
- 10 (4) This section does not apply to constitutionally protected
- 11 activity, including, but not limited to, engaging in reporting,
- 12 news gathering, protesting, lobbying, advocacy, or other activities
- 13 intended to inform or influence the public or public officials,
- 14 including election officials, on matters of public interest or
- 15 public concern.
- 16 (5) As used in this section:
- 17 (a) "Duties" include, but are not limited to, any of the
- 18 following:
- 19 (i) Creating, disseminating, collecting, or delivering
- 20 applications or ballots, including absent voter ballots or absent
- 21 voter ballot applications.
- (ii) Registering voters.
- 23 (iii) Opening, closing, and maintaining order at polling places,
- 24 early voting sites, and absent voter counting board locations.
- 25 (iv) Processing and assisting voters at polling places or early
- 26 voting sites.
- 27 (v) Processing and tabulating ballots at polling places, early
- 28 voting sites, and absent voter counting board locations.
- 29 (vi) Tallying ballots at polling places and absent voter

- 1 counting board locations.
- 2 ($v\ddot{u}$) Certifying election results by a board of county 3 canvassers or the board of state canvassers.
- 4 (b) "Election official" means a public officer, public
 5 employee, election inspector, member of the board of state
 6 canvassers, member of a board of county canvassers, member of an
 7 absent voter counting board, or a county, city, or township clerk
 8 who has a duty to perform in connection with an election conducted
 9 under this act.
- 10 (c) "Intimidate" means a willful course of conduct involving
 11 harassment of another individual that is intended to cause the
 12 individual to fear physical injury, that would cause a reasonable
 13 individual to fear physical injury, and that actually causes the
 14 individual to fear physical injury. Intimidate does not include
 15 constitutionally protected activity or conduct that serves a
 16 legitimate purpose.
