THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17744b. (1) Notwithstanding any provision of this act to
- 2 the contrary, a prescriber may issue a prescription for and a
- 3 dispensing prescriber or pharmacist may dispense an opioid
- 4 antagonist to any of the following:

- 1 (a) An individual patient at risk of experiencing an opioid-2 related overdose.
- (b) A family member, friend, or other individual in a position 3 to assist an individual at risk of experiencing an opioid-related 4 overdose.
- 6 (c) A person other than an individual that meets all of the 7 following requirements:
- 8 (i) Acts at the direction of the prescriber or dispensing 9 prescriber.

- 10 (ii) Upon receipt of an opioid antagonist, stores the opioid antagonist in compliance with this part. 11
- 12 (iii) Dispenses or administers an opioid antagonist under a valid prescription issued to an individual or a patient. 13
- 14 (iv) Performs the requirements under this subsection without 15 charge or compensation.
- (d) An agency authorized to purchase or otherwise obtain, 16 17 possess, and distribute an opioid antagonist under the administration of opioid antagonists act, 2019 PA 39, MCL 15.671 to 18 15.677. 19
 - (2) When issuing a prescription for or dispensing an opioid antagonist as authorized under this section to an agency described in subsection (1)(d) or a person other than a patient, the prescriber, dispensing prescriber, or pharmacist, as appropriate, shall insert the name of the agency or the person as the name of the patient.
- (3) Notwithstanding any provision of this act to the contrary, 26 27 a person that is acting in good faith and with reasonable care may 28 possess and dispense an opioid antagonist.
