June 18, 2024, Introduced by Reps. Xiong, Brabec, Miller, Byrnes, MacDonell, Grant, Rheingans, McKinney, Neeley, Brenda Carter, O'Neal and Bruck and referred to the Committee on Health Policy.

A bill to establish a doula scholarship program for eligible individuals; to provide for the administration of the doula scholarship program; to create the doula scholarship fund; and to prescribe certain powers and duties of certain state officers and entities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Department" means the department of health and human
- 3 services.

(b) "Doula" means an individual who provides continuous

- 1 physical, emotional, and informational support to a mother before,
- 2 during, and shortly after childbirth to help the mother achieve a
- 3 healthy and satisfying childbirth experience.
- 4 (c) "Doula training" means the training an individual
- 5 completes to become a doula and that is approved by the Michigan
- 6 doula advisory council in the department.
- 7 (d) "Eligible costs" means the costs of doula training,
- 8 including, but not limited to, cost of books, workshop fees,
- 9 examination fees, and membership fees.
- 10 (e) "Financial hardship" means insufficient financial
- 11 resources to complete doula training without financial assistance.
- 12 Sec. 3. The doula scholarship program is created, to be
- 13 administered by the department. The department shall do all of the
- 14 following in implementing the scholarship program:
- 15 (a) Award scholarships to eligible individuals under this act.
- 16 (b) Promulgate rules necessary to implement this act pursuant
- 17 to the administrative procedures act of 1969, 1969 PA 306, MCL
- 18 24.201 to 24.328.
- 19 (c) Publicize the availability of the doula scholarship
- 20 program, in partnership with universities, nonprofit organizations,
- 21 and other persons.
- Sec. 5. (1) The department may award a scholarship for
- 23 eligible costs under this act to an individual determined by the
- 24 department to meet all of the following eligibility criteria:
- 25 (a) Has not been awarded a scholarship under this act at the
- 26 time the individual submits an application.
- 27 (b) Demonstrates a financial hardship through household income
- 28 or through receipt of financial assistance under the supplemental
- 29 nutrition assistance program; the special supplemental food program

- 1 for women, infants, and children; the Social Security
- 2 Administration SSI program; or another program.
- 3 (c) Completes a signed application stating an intent to become
- 4 a doula in this state and provides proof of residency in this
- 5 state.
- 6 (d) Meets any other standards established in the rules
- 7 promulgated by the department under section 3.
- 8 (2) An individual may apply for a scholarship under this act
- 9 by completing an application on a form provided by the department.
- Sec. 7. (1) An individual must not receive more than \$3,000.00
- 11 for an award under this act and must not receive more than 1 award
- 12 under this act.
- 13 (2) Not more than 6 months after receiving a scholarship under
- 14 this act, the individual shall be working toward completion of
- 15 doula training or have completed doula training, and shall provide
- 16 the department with documentation demonstrating that the individual
- 17 is serving as a doula or is working toward completion of doula
- 18 training. The department shall accept any of the following as
- 19 documentation required under this subsection:
- 20 (a) A letter from a health care professional who verifies the
- 21 individual is serving as a doula and the health care professional
- 22 works with the individual.
- 23 (b) A letter from a client who received services from the
- 24 individual acting as the client's doula.
- 25 (c) Any other documentation the department determines is
- 26 sufficient to demonstrate the requirements of this subsection.
- 27 (3) If an individual does not comply with subsection (2), the
- 28 department shall seek repayment of the award.
- Sec. 9. (1) The doula scholarship fund is created within the

- 1 state treasury.
- 2 (2) The state treasurer may receive money or other assets from
- 3 any source for deposit into the fund. The state treasurer shall
- 4 direct investment of the fund. The state treasurer shall credit to
- 5 the fund interest and earnings from fund investments.
- 6 (3) Money in the fund at the close of the fiscal year will
- 7 remain in the fund and will not lapse to the general fund.
- 8 (4) The department is the administrator of the fund for
- 9 auditing purposes.
- 10 (5) The department shall expend money from the fund, upon
- 11 appropriation, only for the purpose of providing scholarships under
- 12 this act.
