SUBSTITUTE FOR HOUSE BILL NO. 5887

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 213b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 213b. (1) Except as provided in subsections (2) and (3),
- 2 an individual who intentionally and maliciously threatens to
- 3 release, exhibit, create, or distribute sexually explicit visual
- 4 material of another individual in order to compel or attempt to
- 5 compel another individual to do any act or refrain from doing any
- 6 act against the individual's will with the intent to obtain
- 7 sexually explicit visual material or anything else of value is
- 8 guilty of a felony punishable as follows:
- 9 (a) For a first offense, by imprisonment for not more than 5

- 1 years, a fine of not more than \$5,000.00, or both.
- 2 (b) For a second offense, by imprisonment for not more than 10 years, a fine of not more than \$10,000.00, or both.
- 4 (c) For a third or subsequent offense, by imprisonment for not 5 more than 20 years, a fine of not more than \$20,000.00, or both.
- 6 (2) If an individual commits a violation of subsection (1) and 7 either of the following factors apply, the individual is guilty of 8 a felony punishable by imprisonment for not more than 25 years:
- 9 (a) The victim is less than 18 years of age or a vulnerable 10 adult and the individual who committed the violation is more than 11 18 years of age.
- 12 (b) The victim suffers serious physical harm, serious mental 13 harm, or death as a result of the violation of subsection (1).
- (3) If the individual convicted of a violation of subsection (1) is less than 18 years of age, the individual is guilty of a misdemeanor punishable by imprisonment for not more than 1 year. The court may order behavioral health counseling from an
- appropriate agency or provider as part of an individual's sentence under this subsection.
 - (4) As used in this section:
- 21 (a) "Nudity" means displaying an individual's genitalia or 22 anus or if the individual is a female, her nipples or areola.
- 23 (b) "Serious mental harm" means a mental injury that results 24 in a substantial alteration of mental functioning that is 25 manifested in a visibly demonstrable manner.
- 26 (c) "Serious physical harm" means a physical injury that
 27 threatens the life of a victim, causes substantial bodily
 28 disfigurement, or seriously impairs the functioning or well-being
 29 of the victim.

- 1 (d) "Sexually explicit visual material" means a photograph or 2 video that depicts nudity, erotic fondling, sexual intercourse, or 3 sadomasochistic abuse.
- 4 (e) "Vulnerable adult" means that term as defined in section 5 145m.
