March 15, 2023, Introduced by Senators IRWIN, HAUCK, MOSS, BAYER, WOJNO, SANTANA and MCMORROW and referred to the Committee on Regulatory Affairs.

A bill to amend 2018 IL 1, entitled "Michigan Regulation and Taxation of Marihuana Act," by amending section 14 (MCL 333.27964).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 14. (1) 1.—The marihuana regulation fund is created in
- 2 the state treasury. The department of treasury shall deposit into
- 3 the fund all money collected under section 13 and all money
- 4 collected by the department of treasury in accordance with an
- 5 agreement described in section 3(y) (ii), of this act and the
- 6 department cannabis regulatory agency shall deposit into the fund

- 1 all fees collected in the fund. under this act. The state treasurer
- 2 shall direct the investment of the fund and shall credit to the
- 3 fund interest and earnings from fund investments. The department
- 4 cannabis regulatory agency shall administer the fund for auditing
- 5 purposes. Money in the fund shall at the close of the fiscal year
- 6 must remain in the fund and must not lapse to the general fund.
- 7 (2) 2. Funds for the initial activities of the department
- 8 cannabis regulatory agency to implement this act shall be
- 9 appropriated from the general fund. The department cannabis
- 10 regulatory agency shall repay any amount appropriated under this

- 26 under this subdivision.
- 27 (4) Upon appropriation, the unexpended balances in the fund

- 16 attributable to the marihuana retailer or marihuana microbusiness
- 17 that would have otherwise been allocated to a municipality under
- 18 subsection (4)(a) and a county under subsection (4)(b) must instead
- 19 be allocated to the Indian tribe in whose Indian lands the
- 20 marihuana retailer or marihuana microbusiness is located.
- 21 Enacting section 1. This amendatory act does not take effect
- 22 unless Senate Bill No. 180 of the 102nd Legislature is enacted into
- 23 law.
