SUBSTITUTE FOR SENATE BILL NO. 464

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803r (MCL 257.803r), as amended by 2023 PA 129 and by adding section 803s.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803r. The secretary of state shall deposit the service
- 2 fees collected under sections 803e, 803f, 803i, 803j, 803k, 803l,
- **3** 803m, 803n, and 803s(2)(a) into the transportation
- 4 administration collection fund created under section 810b through
- **5** October 1, 2027.
- 6 Sec. 803s. (1) Not later than 1 year after the effective date
- 7 of the amendatory act that added this section, the secretary of
- 8 state shall develop and issue the following legacy registration

- 1 plates:
- 2 (a) A blue registration plate that replicates a registration
- 3 plate issued by this state during the years 1983 to 2007 as
- 4 determined by the secretary of state.
- 5 (b) A black registration plate that replicates a registration
- 6 plate issued by this state during the years 1979 to 1983 as
- 7 determined by the secretary of state.
- 8 (c) Only available for issue in the year 2026 to celebrate the
- 9 United States' semiquincentennial, a red, white, and blue
- 10 registration plate that replicates a registration plate issued by
- 11 this state during the year 1976 as determined by the secretary of
- 12 state.
- 13 (2) An application for a legacy registration plate must be
- 14 submitted to the secretary of state pursuant to the procedures
- 15 prescribed in section 217. In addition to the regular registration
- 16 fee, an application for a legacy registration plate under this
- 17 section must be accompanied by the following, as applicable:
- 18 (a) For a new legacy registration plate, a service fee of
- 19 \$5.00.
- 20 (b) For a new legacy registration plate, an additional fee of
- 21 \$50.00. The additional fee must be deposited in the Michigan
- 22 transportation fund established under section 10 of 1951 PA 51, MCL
- 23 247.660.
- 24 (c) For a registration renewal of an existing legacy
- 25 registration plate, an additional fee of \$10.00. The additional fee
- 26 must be deposited in the Michigan transportation fund established
- 27 under section 10 of 1951 PA 51, MCL 247.660.
- 28 (3) A legacy registration plate expires as provided in section
- 29 226.

- 1 (4) The secretary of state shall determine the number of each 2 legacy registration plate to be manufactured and issued under this 3 section.
- 4 (5) The secretary of state may, as determined necessary by the 5 secretary of state, cease to issue legacy registration plates and 6 duplicate replacements of legacy registration plates for use on
- 7 vehicles. If the secretary of state ceases to issue legacy
- 8 registration plates and duplicate replacements of legacy
- 9 registration plates, the secretary of state may continue to renew
- 10 legacy registration plates already issued.
