## **SENATE BILL NO. 528**

September 26, 2023, Introduced by Senators SHINK and CHANG and referred to the Committee on Civil Rights, Judiciary, and Public Safety.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending sections 115, 145n, 377a, 380, 411h, and 540e (MCL 750.115, 750.145n, 750.377a, 750.380, 750.411h, and 750.540e), section 115 as amended by 2000 PA 148, section 145n as amended by 2016 PA 480, sections 377a and 380 as amended by 1998 PA 311, section 411h as amended by 1997 PA 65, and section 540e as amended by 2002 PA 577.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 115. (1) Any person An individual who breaks and enters

- 1 or enters without breaking, any dwelling, house, tent, hotel,
- 2 office, store, shop, warehouse, barn, granary, factory or other
- 3 building, boat, ship, railroad car or structure used or kept for
- 4 public or private use, or any private apartment therein, or any
- 5 cottage, clubhouse, boat house, hunting or fishing lodge, garage or
- 6 the out-buildings belonging thereto, any ice shanty with a value of
- 7 \$100.00 or more, or any other structure, whether occupied or
- 8 unoccupied, without first obtaining permission to enter from the
- 9 owner or occupant, agent, or person having immediate control
- 10 thereof, is guilty of a misdemeanor.
- 12 (2) If an individual violates subsection (1) and the owner or 12 occupant, agent, or person having immediate control thereof is the 13 individual's spouse or former spouse, an individual with whom the 14 individual has or has had a dating relationship, an individual with 15 whom the individual has or has had a child in common, or a resident
- 16 or former resident of the individual's household, the individual is
- 17 guilty of a misdemeanor.

- 19 without breaking, any place which at the time of the entry was open

- 2 Sec. 145n. (1) A caregiver is quilty of vulnerable adult abuse
- 3 in the first degree if the caregiver intentionally causes serious
- 4 physical harm or serious mental harm to a vulnerable adult.
- 5 Vulnerable adult abuse in the first degree is a felony punishable
- 6 by imprisonment for not more than 15 years or a fine of not more
- 7 than \$10,000.00, or both.

- 8 (2) A caregiver or other person with authority over the
- 9 vulnerable adult is guilty of vulnerable adult abuse in the second
- 10 degree if the reckless act or reckless failure to act of the
- 11 caregiver or other person with authority over the vulnerable adult

- 22 vulnerable adult is quilty of vulnerable adult abuse in the fourth
- 23 degree if the reckless act or reckless failure to act of the
- 24 caregiver or other person with authority over a vulnerable adult
- 25 causes physical harm to the vulnerable adult or the caregiver or
- 26 other person with authority over the vulnerable adult knowingly or
- 27 intentionally commits an act that under the circumstances poses an
- 28 unreasonable risk of harm or injury to a vulnerable adult,
- 29 regardless of whether physical harm results. Vulnerable adult abuse

- 21 by imprisonment for not more than 1 year or a fine of not more than

- 8 Sec. 377a. (1) A person who willfully and maliciously destroys
- 9 or injures the personal property of another person is guilty of a
- 10 crime as follows:
- 11 (a) If any of the following apply, the person is guilty of a
- 12 felony punishable by imprisonment for not more than 10 years or a
- 13 fine of not more than \$15,000.00 or 3 times the amount of the
- 14 destruction or injury, whichever is greater, or both imprisonment
- 15 and a fine:
- 16 (i) The amount of the destruction or injury is \$20,000.00 or
- **17** more.
- 18 (ii) The person violates subdivision (b) (i) and has 2 or more
- 19 prior convictions for committing or attempting to commit an offense
- 20 under this section. For purposes of this subparagraph, however, a
- 21 prior conviction does not include a conviction for a violation or

- (d) If the person and the property owner are spouses or former spouses, have or have had a dating relationship, have or have had a child in common, or are residents or former residents of the same household, and any of the following apply, the person is guilty of a misdemeanor punishable by imprisonment for not more than 1 year or a fine of not more than \$2,000.00 or 3 times the amount of the destruction or injury, whichever is greater, or both imprisonment and a fine:
- 25 (i) The amount of the destruction or injury is \$200.00 or more 26 but less than \$1,000.00.

- 27 (a) "Course of conduct" means a pattern of conduct composed of

- 29 continuity of purpose.

(b) "Dating relationship" means frequent, intimate associations primarily characterized by the expectation of affectional involvement. This term does not include a casual relationship or an ordinary fraternization between 2 individuals in a business or social context.

- (c) (b) "Emotional distress" means significant mental
   suffering or distress that may, but does not necessarily, require
   medical or other professional treatment or counseling.
- 9 (d) (e)—"Harassment" means conduct directed toward a victim
  10 that includes, but is not limited to, repeated or continuing
  11 unconsented contact that would cause a reasonable individual to
  12 suffer emotional distress and that actually causes the victim to
  13 suffer emotional distress. Harassment does not include
  14 constitutionally protected activity or conduct that serves a
  15 legitimate purpose.
  - (e) (d)—"Stalking" means a willful course of conduct involving repeated or continuing harassment of another individual that would cause a reasonable person to feel terrorized, frightened, intimidated, threatened, harassed, or molested and that actually causes the victim to feel terrorized, frightened, intimidated, threatened, harassed, or molested.
    - (f) (e) "Unconsented contact" means any contact with another individual that is initiated or continued without that individual's consent or in disregard of that individual's expressed desire that the contact be avoided or discontinued. Unconsented contact includes, but is not limited to, any of the following:
  - (i) Following or appearing within the sight of that individual.
- (ii) Approaching or confronting that individual in a public place or on private property.

- 1 (iii) Appearing at that individual's workplace or residence.
- 2 (iv) Entering onto or remaining on property owned, leased, or3 occupied by that individual.
- 4 (v) Contacting that individual by telephone.

- (vi) Sending mail or electronic communications to that individual.
- 7 (vii) Placing an object on, or delivering an object to, 8 property owned, leased, or occupied by that individual.
- 9 (g) (f) "Victim" means an individual who is the target of a
  10 willful course of conduct involving repeated or continuing
  11 harassment.
- 12 (2) An individual who engages in stalking is guilty of a crime 13 as follows:
- (a) Except as provided in subdivision (b), a misdemeanor
  punishable by imprisonment for not more than 1 year or a fine of
  not more than \$1,000.00, or both.
- 17 (b) If the victim was less than 18 years of age at any time
  18 during the individual's course of conduct and the individual is 5
  19 or more years older than the victim, a felony punishable by
  20 imprisonment for not more than 5 years or a fine of not more than
  21 \$10,000.00, or both.
  - (c) If the victim and the individual are spouses or former spouses, have or have had a dating relationship, have or have had a child in common, or are residents or former residents of the same household, a misdemeanor punishable by imprisonment for not more than 1 year or a fine of not more than \$1,000.00, or both.

- 11 (4) In a prosecution for a violation of this section, evidence 12 that the defendant continued to engage in a course of conduct involving repeated unconsented contact with the victim after having 13 14 been requested by the victim to discontinue the same or a different 15 form of unconsented contact, and to refrain from any further 16 unconsented contact with the victim, gives rise to a rebuttable presumption that the continuation of the course of conduct caused 17 18 the victim to feel terrorized, frightened, intimidated, threatened, 19 harassed, or molested.
- (5) A criminal penalty provided for under this section may be
  imposed in addition to any penalty that may be imposed for any
  other criminal offense arising from the same conduct or for any
  contempt of court arising from the same conduct.
- Sec. 540e. (1) A person is guilty of a misdemeanor who
  maliciously uses any service provided by a telecommunications
  service provider with intent to terrorize, frighten, intimidate,
  threaten, harass, molest, or annoy another person, or to disturb
  the peace and quiet of another person by doing any of the following
  is quilty of a misdemeanor:

- (a) Threatening physical harm or damage to any person or
   property in the course of a conversation or message through the use
   of a telecommunications service or device.
- 4 (b) Falsely and deliberately reporting by message through the
  5 use of a telecommunications service or device that a person has
  6 been injured, has suddenly taken ill, has suffered death, or has
  7 been the victim of a crime or an accident.
- 8 (c) Deliberately refusing or failing to disengage a connection
  9 between a telecommunications device and another telecommunications
  10 device or between a telecommunications device and other equipment
  11 provided for the transmission of messages through the use of a
  12 telecommunications service or device.
- (d) Using vulgar, indecent, obscene, or offensive language or suggesting any lewd or lascivious act in the course of a conversation or message through the use of a telecommunications service or device.
  - (e) Repeatedly initiating a telephone call and, without speaking, deliberately hanging up or breaking the telephone connection as or after the telephone call is answered.

- (f) Making an unsolicited commercial telephone call that is received between the hours of 9 p.m. and 9 a.m. For the purpose of As used in this subdivision, "an unsolicited commercial telephone call" means a call made by a person or recording device, on behalf of a person, corporation, or other entity, soliciting business or contributions.
- (g) Deliberately engaging or causing to engage the use of a telecommunications service or device of another person in a repetitive manner that causes interruption in telecommunications service or prevents the person from utilizing his or her the

- 1 person's telecommunications service or device.
- 2 (h) Engaging in any of the conduct prohibited under
- 3 subdivisions (a) to (g) if the person and the other person are
- 4 spouses or former spouses, have or have had a dating relationship,
- 5 have or have had a child in common, or are residents or former
- 6 residents of the same household. As used in this subdivision,
- 7 "dating relationship" means frequent, intimate associations
- 8 primarily characterized by the expectation of affectional
- 9 involvement. This term does not include a casual relationship or an
- 10 ordinary fraternization between 2 individuals in a business or
- 11 social context.
- 12 (2) A person violating person who violates this section may be
- 13 imprisoned for not more than 6 months or fined not more than
- 14 \$1,000.00, or both. An offense is committed under this section if
- 15 the communication either originates or terminates in this state and
- 16 may be prosecuted at the place of origination or termination.
- 17 (3) As used in this section, "telecommunications",
- 18 "telecommunications service" and "telecommunications device" mean
- 19 those terms as defined in section 540c.
- 20 Enacting section 1. This amendatory act does not take effect
- 21 unless Senate Bill No. 471 of the 102nd Legislature is enacted into
- **22** law.
